- Records for learners benefiting from other EFA funding should be returned at each collection where the EFA and/or national statistics is indicated in the main data use
- Records for learners benefiting from other Skills Funding Agency funding should be returned monthly by private training providers and every three months and at the end of the year by colleges, that is at return numbers R04, R06, R10, R13 and R14.
- Records for learners not benefiting from EFA or Skills Funding Agency funding should be returned monthly by private training providers and every three months and at the end of the year by colleges, that is at R04, R06, R10, R13 and R14
