Engaging with key stakeholders & data users – Summary of DWP's activities since the last meeting

This section illustrates how we are working with key stakeholders including data users to help inform what demand there is for our data and the priority users attach for the timing of its release. We are also using feedback from sources such as registered users on Stat-Xplore to data.gov.uk analytics to assess how popular our data is and identify further improvements

Achievements / Work completed since the last meeting

- (3.2.1) DWP Open Data Group (formerly External Stakeholder Group) met on 26.9.13 .The group has expanded it's external members from 8 to 15
- (3.3.1) In September DWP attended the Energy & Environment Open Data Policy workshop
- (3.4.2) Stat-Xplore over 500 registered users feedback received has resulted in several improvements including introducing a hierarchy for geographical breakdowns, increasing size of tables for guest users
- (3.4.5) Received 8 ODUG requests which have been responded to
- (3.4.7) Met all cross government publishing requirements for the quarterly written ministerial statement period QTR1 2013/14. Also released new data for customer complaints and GMPP outlined in the 2012 OD Strategy
- (3.4.8) Feedback from customers on-line access latest feedback shows we have achieved the 80% JSA online target one month early (82.5% in month)

Feedback from Data.gov.uk

Two DWP data sets reviewed by users:

A Greater London Authority rep said that **Winter Fuel Payments data** would help detect trends in older people claiming – they seek aggregate stats.

New Philanthropy Capital (NPC) - an organisation "working to aid charities show their impact by making data more available & user friendly" - seek access to **Universal Credit data** by non-profit bodies who work to support people into employment. Also suggest linking UC data to Police and National Drug Monitoring Systems.

Contributed to the Government's National Information Infrastructure and developing the inventory of public datasets for assessment by users on data.gov.uk. Alerting external stakeholders WSTB and DWP Open Data Group of the opportunity to assess our 'unpublished' datasets on data.gov.uk

Drafted the refresh of the Open Data Strategy outlining DWP's future transparency / open data commitments. The Strategy links to DWPs commitments in the National Information Infrastructure and is split into the following key headers:

Wider Activities – Summary of DWP's activities since the last meeting

This section illustrates the wider activities DWP are undertaking to drive forward the transparency / open data agenda including the growth review measures, Universal Credit, Fit Note data outlined in the Autumn Statement 2011. It includes progress on DWP's data sharing activities and continuing support to the Admin Data Task Force (ADTF) for wider welfare provision

Growth Review Measures

(5.1.1) Universal Credit

First set of Official Stats that could contain UC is intended to be released approx 9 moths after admin data relating to UC is available to DWP statisticians

(5.2.1) Fit Note data

Once fit note data is secured from DH a start date for publishing can be agreed

(5.3.1 & 5.3.2) Linking welfare datasets / Opening up DWP data for wider research

DWP is starting a small pilot to test a new process for sharing data with third party researchers outside of the Data Archive, which is non personal but richer and more sensitive data than we can make freely available.

To support this DWP has completed the process to give the Institute for Fiscal Studies (IFS) access to the Family Resource Survey (FRS) for research purposes.

Population census beyond 2011 – next key milestone completion of Beyond 2011 Report in Spring 2014

Warm Home Discount – now provide a data checking solution for the Energy Company Obligation to enable accurate referrals to suppliers

Benefit Fraud Activities – DWP looking to share details of known fraudsters across the banking, insurance, policing and welfare sectors to help combat multiiple sector fraud
