FREEDOM OF INFORMATION ACT 2000

I refer to your e-mail of 18th May 2011 requesting information, which we have dealt with under the terms of the Freedom of Information Act 2000.

You asked for information relating to the number of private vehicle MOT test stations and goods vehicle testing facilities in the UK for each year from 2000 to 2010 and a further breakdown of the classes of vehicle each can test.

The database of garages undertaking MOT testing of cars and motorcycles etc is a "living document". In other words, we only know the precise number of authorised test stations as of now. Each year in the VOSA Effectiveness Report, available on our website, we publish a "snapshot" of the number of garages authorised to conduct MOT testing. The Effectiveness Report for each financial year can be found within the Corporate Reports Suite available on the VOSA website under publications.

VOSA also publishes the number of testing facilities available for HGV testing. In the most recent report, the information can be found in Table 4.18, this can be accessed by clicking on the following link
