## What this booklet is about

The Department for Work and Pensions asked Doctor Paul Litchfield to look at how the **Work Capability Assessment** is working. And to give us some ideas to make it better.

#### Work Capability Assessment


This is when people talk to a health expert about their health and how it affects them. And if they could move into work or if they should get the **Employment and Support Allowance**.

#### Employment and Support Allowance

This is a benefit for disabled people and people who have a health condition. People will get this benefit if they do not have a job and they cannot work at all, or cannot work now but could work some time in the future.

Asking people what they think about the **Work Capability Assessment** is just one of the ways Doctor Litchfield will use to see how it is working.

We started to ask people what they think about the **Work Capability Assessment** on 1 July 2013. We will stop asking people what they think on 27 August 2013.



## What you need to know

## The Employment and Support Allowance and the Work Capability Assessment

The **Employment and Support Allowance** began in October 2008. It is for disabled people and people with a health condition.

The Work Capability Assessment looks at people's health. It shows if people should go into the **support group**, the **work related activity group** or if they are fit for work.

#### Support group

This is a group of people who will not be expected to work but can get help to find work if they want it.

#### Work related activity group

This is a group of people who may be able to work in the future. They will get help to get ready for work.



#### About the reviews of the Work Capability Assessment

There have been 3 reviews of the Work Capability Assessment. These were carried out between 2010 and 2012.

The reviews have given us some ideas for making the **Work Capability Assessment** better.

We agreed with most of the ideas to make the **Work Capability Assessment** better. Doctor Litchfield wants to see what effect these have had.

Doctor Litchfield wants to do these things.

- He wants to look at how good the **Work Capability Assessment** is at finding out if people can work.
- He wants to find out if the Work Capability Assessment works well with people who have mental health conditions and disabilities.

#### Mental health condition

These are feelings that make people feel unhappy or behave in a way that has a bad effect on the way they want to live their lives. These difficulties are caused by many different things.




Is the **Work Capability Assessment** good at finding out which people should be in the **support group**?


Is the Work Capability Assessment good at finding out which people should be in the work related activity group?


#### Question 3c

#### Question 5

What changes have you seen in the way the **Work Capability Assessment** works because of what people said in the first 3 reviews of the **Work Capability Assessment**.

A lot of people who ask to get the Employment and Support Allowance have a mental health condition.

How do you think **mental health conditions** are thought about during the **Work Capability Assessment**?

A disabled person may or may not be able to work. It can depend on these things.

- The disabled person's medical condition.
- The way the disabled person feels about themselves.
- How society helps them.

#### Society

**Society** means all the people and all parts of life in this country. Being part of **society** can mean being accepted and having your views listened to. It can mean being able to live where you want, vote for a government, or join a group. When people are accepted by others this makes a good **society**.

Do you think the **Work Capability Assessment** takes enough account of the way people feel about themselves and how **society** helps them?

If you do not think it does, please tell us how you think it should.

We can decide if people should be in the **support group** or the **work related activity group** in 2 ways.

We could look at whether a person's disability makes it very hard to carry out a single activity. We call this a criterion-based approach.

Or we could look at whether a person's disability affects them in lots of different ways. We call this a points-based approach.

What do you think about these 2 ways of working out which group a person should be in?

Do you think one way is better then the other, or do you think we should we use both ways?

Think about the whole process. It starts when you make a claim for the **Employment and Support Allowance** and it ends when the Department for Work and Pensions tells you the result of the claim for the **Employment and Support Allowance**.

What do we need to do to make the Work Capability Assessment better?

What other changes do you think we need to make?

Is there anything else you would like to tell us about the Work Capability Assessment?


