Thank you for your request for information about the tunnel complex at Rhydymwyn, which we received on 20 August 2013. As you know, we have handled your request under the Freedom of Information Act 2000 (FOIA).

There is limited correspondence on proposed future inspection / engineering work relevant to the Rhydymwyn Tunnels, supplied. However it is anticipated the current regime of annual inspections, review of recommendations and implementations of remedial works will continue.

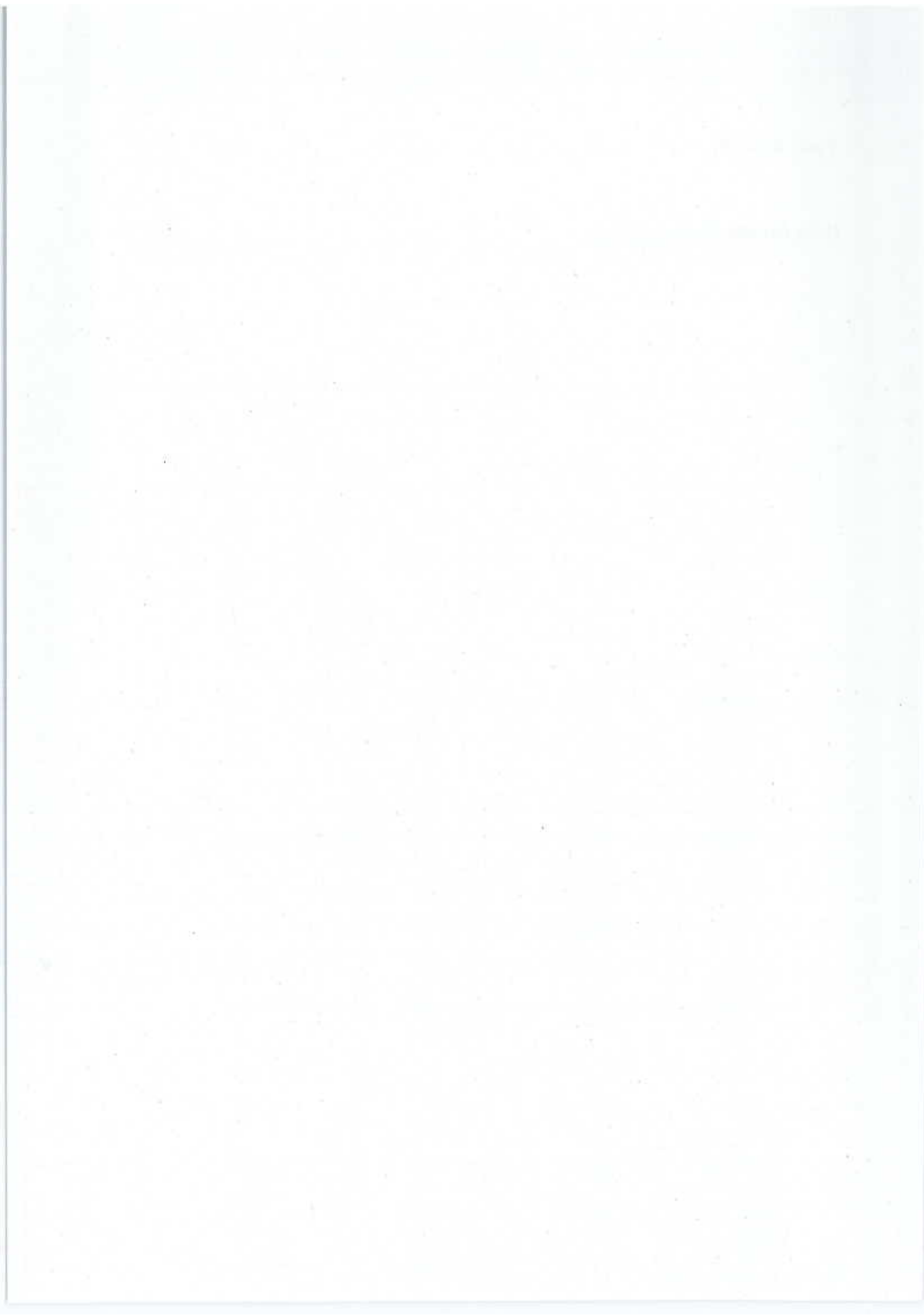
