FINANCIAL SANCTIONS: FEDERAL REPUBLIC OF YUGOSLAVIA AND SERBIA

Following the publication of EC Regulation No.1205/2001 in the Official Journal of the European Communities on 20 June, financial sanctions against the Federal Republic of Yugoslavia and Serbia have been further modified to cover only those funds belonging to the former President of the FRY, Mr Slobodan Milosevic, and certain members of his family and other close associates.

COMMISSION REGULATION (EC) NO 1205/2001

FRY AND SERBIA

21 June 2001

- On 19 June 2001 the Commission of the European Communities adopted Commission Regulation (EC) No 1205/2001 which amended Council Regulation (EC) No 2488/2000 with the effect of reducing the number of individuals targeted by the freeze on funds belonging to the former President of the FRY, Mr Slobodan Milosevic and certain persons associated with him. The persons now covered by the freeze are listed in the Annex to the amending Regulation, which was published in the Official Journal of the European Communities on 20 June 2001 (reference L163/14).
- 2. A copy of the amending Regulation is attached to this Notice.
- 3. Regulation (EC) No 2488/2000 applies to any person who is a national of a Member State, to any body which is incorporated or constituted under the law of a Member State, on board any aircraft or any vessel under the jurisdiction of a Member State and to everyone within the territory of the Community including its air space.

FRY Accounts

4. The sterling or foreign currency accounts of the former President of the FRY, Mr Slobodan Milosevic, and the persons listed in the Annex to the new Regulation, held in the United Kingdom by persons which have been authorised by the Financial Services Authority, or by European authorised persons, should be designated as FRY Accounts. Funds held by solicitors, accountants and other persons should be treated similarly.

Payments involving FRY Accounts

5. Payments to or from FRY Accounts are prohibited unless permitted by an exemption granted by the European Commission for humanitarian purposes.

Provision of information

6. All banks, financial institutions, other bodies and persons in the UK should inform the Bank of England of all accounts that they have blocked in accordance with Council Regulation (EC) No 2488/2000 as now amended.
