People on Secondment from named organisations

I can confirm that between 1 January 2010 and 20 May 2013 two people have been seconded to the Department of Energy & Climate Change (DECC) from the above organisations. The details of these secondments are shown in the table below.

I can confirm that DECC was meeting the salary costs of both people whilst they were on secondment to DECC and that these costs were reimbursed to their employer. We consider the salary details of people working on secondment into DECC to be personal information which is being withheld under section 40 of the Act, as the information constitutes third party data. Section 40 of the Act provides an absolute exemption for personal data which then falls to be dealt with under the Data Protection Act. Personal data of third parties can only be disclosed in accordance with the data protection principles. In particular, the first data protection principle requires that disclosure must be fair and lawful and must comply with one of the conditions in Schedule 2 of the Data Protection Act. We do not think that it is fair to release the salary details of people on secondment into DECC and do not think that any of the relevant conditions apply.

Appeals procedure

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to the Security & Information Rights Unit (foi@decc.gsi.gov.uk).
