

## Latest thinking.....

Since our last newsletter DVLA has been engaged in understanding the impact and opportunities presented with the introduction of the core Government Procurement Services (GPS) frameworks\*. The introduction of the new frameworks has helped shape the current thinking for the DVLA tower model and how DVLA intends to move forward.

We have previously been asked by the market to explain:

1. What the Technology Deliver Partner (TDP) role will be and how it will fit with the Systems Integration & Management (SIAM) function
2. How the tower model will be shaped
3. How more specialist suppliers may fit into the new target operating model

Page 2 & 3 of this newsletter give our latest view. Although set at a high level we felt that it was important to share the emerging picture.

## Timeline.....

The TDP function will be procured and in place in early 2013. Other elements of the new target operating model may be procured in advance of the expiry of DVLA's main ICT contract.

## Role of the TDP

- Working at a strategic level to help deliver a strong client function at DVLA
- Facilitating skills transfer into DVLA to enhance the existing commercial, business and technical capability

## Role of the SIAM

- To manage the end to end integration of services across a multi vendor supported tower model
- Should DVLA buy in the SIAM expertise it will likely be procured through a GPS framework. You may wish to consider tendering for the GPS SIAM framework

## Tower Model

- DVLA intend to procure the 3 vertical towers illustrated on Page 2 through the GPS frameworks. Again you may wish to consider tendering for the appropriate GPS framework
- The horizontal towers illustrated on Page 3 will be constructed to have the flexibility to enable procurement of specialist supplier services as and when required. The GPS framework will be the default procurement route

## Pre-Procurement Engagement

- A TDP awareness event is currently planned to take place in October 2012
- Further pre-procurement events will take place as the process progresses
- As part of the commissioning model DVLA intends to allow suppliers to showcase innovation to demonstrate how their offering can fit with the Agency transformation. Timings and arrangements for the events are yet to be defined

#### Strategic Vision

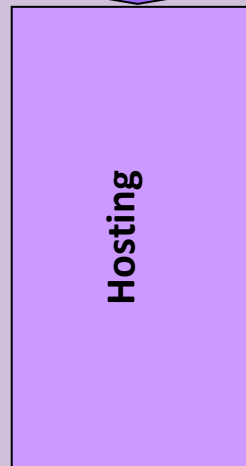
- ✓ Will be set by DVLA in alignment with Cabinet Office and DfT strategy
- ✓ Will focus on the transition to a digital by default organisation



- ✓ Supplier or suppliers with specialist knowledge to be appointed either from existing frameworks or via open competition
- ✓ Focus will be on shaping transformation and enhancing DVLA skill sets



- ✓ Will likely be procured via GPS framework if DVLA go to the market for this function



- ✓ Will likely be procured via the GPS frameworks
- ✓ Where appropriate T&Cs will be tailored to fit DVLA requirements
- ✓ Assumes multiple suppliers in each tower as appropriate
