## **Preparation**

#### **Links to Common Core**

### Childhood Neglect: Improving Outcomes for Children

# **Learning Outcomes**

To assess the nature and extent of a child's developmental needs.

#### **Process**

This exercise aims:

- To enable participants to better understand neglect and its impact on young people.
- To improve skills in assessment and analysis of information.
- To promote multi-agency information sharing and working.
- To raise participants' awareness of local support services.

Trainers may want to localise information with references to names of local police teams, shops, GP surgery for example.

Split the participants into 4 or 6 groups, preferably of mixed disciplines. Give half the groups the Evans family case study and half the Henderson/Miller/Taylor family case study. Ask them to read the case study and to see if they can use it as a basis for completing the Adolescent Wellbeing Scale (Birleson 1980), which can be found in the Family Pack of Questionnaires and Scales (Department of Health, Cox and Walker 2002). Ask them to consider how earlier experiences may have affected current functioning.

#### **Process** Continued ▶

Play them the audio of each young person's story from their perspective and continue the discussion in the light of the additional information.

For Liam's story, ensure feedback includes references to:

- Better information sharing between children's social care, school, police, Youth Offending Teams, Health, Youth Services draw out other relevant agencies.
- Assessment of developmental need, including risk and protective factors based upon information from agencies, parent and young person.
- Referral to appropriate support services and positive activity providers for Liam.
- Parenting support and advice for parents.
- Ask Liam what he wants!

For Michelle's story, ensure feedback includes references to:

- Consideration of which agencies are already involved with Michelle and her family and whether there are other agencies that could be important to involve, social care, health, further education, housing, benefits advisor.
- Consideration of how best to engage with Jim.
- Assessment of developmental needs, including risk and protective factors in place for Michelle and for her unborn baby, based upon information from agencies, parent, other significant people and young person.
- Referral to appropriate support services and positive activity providers for Michelle, such as support services for young mothers, further education opportunities, parent and baby groups, befriending.
- Consideration of Michelle's role with regard to her siblings, including assessment of the attachment relationships and ongoing relationships.
- Ask Michelle what she wants and needs!
