Information requested:

The purpose of this response is to provide you with information regarding the steps taken as part of the review and quality assurance process for the research report "Household food security in the UK – a review of food aid".

The work was commissioned by Defra in February 2013, having been put out to open competition online in December 2012.

All Government research reports are required to go through an appropriate review and quality assurance process prior to publication. The purpose of this process is to provide assurance that the work and the evidence that underpins it has been thoroughly considered by relevant parties. A draft of the report was submitted to the Department in June 2013, and the iterative review process was carried out between June 2013 and February 2014. This process included external academic peer review and consideration across Government Departments, with any comments or requests for clarification submitted back to the research team for consideration. The final version of the report was agreed on 19 February 2014.

This process has now been completed, and as a result on the 20 February 2014 the work was published on the Government's website at:
