

## **Financial Sanctions Notice**

## Liberia

## Introduction

1. Council Regulation (EC) 872/2004, the Regulation imposing financial sanctions against Liberia has been amended so that an asset freeze no longer applies to the person listed in the annex to this Notice.

## Notice summary (Full details are provided in the annex to this Notice).

- 2. The following entry has been <u>removed</u> from the consolidated list and is no longer subject to an asset freeze.
  - UREY, Benoni (Group ID 8051) has been <u>removed</u> from the consolidated list and is no longer subject to an asset freeze.

## Legislative details

- On 5 February 2014 Commission Implementing Regulation (EU) No 102/2014 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 34, 5.2.2014, p.4) by the European Commission.
- 4. The Amending Regulation amended Annex I to Council Regulation 872/2004, with effect from 6 February 2014.
- The Amending Regulation reflects the decision made on 23 December 2013 by the United Nations Security Council (UNSC) Committee established pursuant to Resolution 1521 (2003) to remove 1 individual from the UN Liberia list.
