Change Title: Create new data item `Assessment Authorisation Date'

**Data item / Rule Number:** New item, applicable for LA systems only. This data item is not required in school systems.

#### Description of change:

The Children in Need (CIN) Census collects data on children who are referred to Children's Social Care services. Following consultation, the Government's statutory guidance, Working Together to Safeguard Children (2013), has changed. There will no longer be a requirement to conduct separate `Initial' and `Core' assessments when children are referred. Assessments may now be completed in a single assessment (this is known as a `continuous' assessment). The timeframe for the assessment process is 45 working days from the point of referral. This flexibility comes into practice from 15 April 2013. The new data item `Assessment Authorisation Date' will allow a record to be made of the authorisation date for the assessment when a continuous assessment is reported by the LA (other RFCs are being raised to allow the collection of a start date and a review date). (NB: For the 2013-14 CIN Census, Initial and Core Assessments will still be available for LAs to use; for future collections only a Single assessment module will be available – LAs will record one start, review and end date even if they use multiple assessments internally).

#### Reason for change (including benefits):

Data collected at a national level is of value to LAs and others as part of a wider system of improvement and accountability. Collecting and holding information centrally as with the CIN census data enables valuable local comparisons to be made that would otherwise be very difficult without the structure of a centrally defined data collection. It enables LAs to have a more robust and richer data source when linked to other central data collections.

A fully completed census allows LAs to better understand variations in social care activity and practice and benchmark themselves against national averages and their peers. LAs can draw from this nationally held data and use comparative information from other LAs to evaluate the effectiveness of their local services to drive commissioning, as well as to improve working practices and improve the outcomes of some their most vulnerable and disadvantaged children. Furthermore, the CIN census can encourage LAs to construct robust systems for collecting information on and monitoring disabled children and other children in need. This will help LAs ensure that they meet their duties under the Disability Discrimination Act 2005.

Since new Working Together guidance has been published (March 2013) (in response to recommendations from Professor Eileen Munro's report, 'A child-centered system') a fully completed Census now requires the flexibility to return start and end of assessment dates via single `continuous' assessments to be possible - for which an `Assessment Authorisation Date' is a vital component. The term `authorisation' rather than `end' date has been agreed previously since this is the data the Department requires to best reflect the end of the assessment. Additionally, while LAs develop appropriate systems and processes, the flexibility to use either Initial/Core Assessments or single (`Continuous') assessments (or both) will be critical for many of them for the 2013-14 CIN Census. Star Chamber was advised of the outcome of new Working Together guidance in March 2013, and agreed that Single Assessment should be used in the CIN Census. So LAs and Suppliers could prepare effectively, `Assessment Authorisation Date' has been included in the 2013-14 Business and Technical specification.

#### Impact of not doing the change:

If the new data item is not introduced, the flexibility to use single assessments to report child assessments as required by new statutory guidance will not be possible.

#### ISB view of the proposed change:

- 1. We recognise the need for the new data in order to allow LAs to comply with new mandatory guidance.
- 2. The ISB does not have standards for Children's Services, however we do have standards for assessments and assessment outcomes that are relevant to this business need.
- 3. In order to meet the business need in a way that provides for "future-proofing", we suggest a restructuring of the data around assessments to align with the structure of the ISB standards:
  - a. Create an "entity" (i.e. a data record) for assessment outcomes, with a CL for "assessment type". Represent this within the CIN standards as a repeating group of data embedded within the child information. The entity, or record, can hold the 3 dates (actual, review and authorisation dates) for each assessment outcome
  - b. This then permits an LA to create a record for each assessment outcome for each child, differentiated by date and type of assessment for each child
  - c. The data collection should then permit transmission of however many assessment outcomes there are for each child.

Were this structure in use now, the business need could have been met by simply introducing a new assessment type value into the assessment type CL. Future changes in practice could similarly easily be introduced with minimal impact on standards and systems. This is an example of how standards can be "future-proofed".
