REQUEST FOR INFORMATION: Information On Horn Lane Monitoring Station.

Thank you for your request for information of 6 January 2014 for information about the "Government's considerations since 1 January 2011 of the likelihood of the Horn Lane site reporting breaches of the daily limit value for particles (PM10) in 2011, 2012, 2013, 2014 and/or future years". You wished to know "for example about any information passing between Defra and the Environment Agency and/or the Mayor of London that may relate to Horn Lane". You also wished to know "For example, does Defra know about the works at the waste management site by Horn Lane being enclosed and moved?"

I have attached electronic versions of the information we hold relating to your request. There are a large number of pages in the documents so if you also wish to receive paper copies please let me know and I will arrange for these to be sent to you.

Please note that some of this information has been withheld for the following reasons:

- it is personal information: we have decided that the names of officials who are not in the senior civil service and persons outside Defra should be withheld under regulations 12(3) and 13(1) (third party personal data) of the EIRs, as the information constitutes personal data relating to third parties. Regulations 12(3) and 13(1) of the EIRs provide that personal data relating to third parties is exempt information if disclosure would breach the Data Protection Act 1998 (DPA). These names have therefore been redacted from the attached documents; or
- it is information that is not within the scope of the request.

In keeping with the spirit and effect of the EIRs, and in keeping with the government's Transparency Agenda, all information is assumed to be releasable to the public unless exempt. Therefore, the information released to you will now be published on www.gov.uk





together with any related information that will provide a key to its wider context. Please note that this will not include your personal data.

I attach Annex A, which explains the copyright that applies to the information being released to you.

I also attach Annex B giving contact details should you be unhappy with the service you have received.
