Hi [REDACTED],

I hope you're well. I just wanted to get in touch to confirm our approach for submitting the tobacco plain packaging consultation responses from our supporters. We would like to use the same methods we discussed last month in that, given the technical difficulties with the email send, we will be providing memory stick of consultation responses with the data formatted as an Excel sheet (to avoid duplication). Thanks again for confirming that each name on this will be counted as an individual response to the consultation.

This memory stick will contain the majority of our online responses but a few days before the consultation closes we will redirect our online consultation response mechanism so that supporter responses are sent directly to the consultation inbox (tobaccopacks@dh.gsi.gov.uk).

We will also be forwarding on email responses we have from doctors. We do not wish to include these responses on the memory stick as many of these response emails are customised which makes forwarding the emails the simplest solution. **We will send over the first 150 of these today as a test, may I give you a call at the end of the day to confirm that they have arrived?** They will all show up as from our mailbox (campaigning@cancer.org.uk) and can be identifies by the subject line:

"As a doctor, I support Cancer Research UK's plain packaging campaign"

On the 10th August we would like to hand deliver the memory stick along with the remaining paper petitions we have with us here (the vast majority of our paper petitions have already been submitted). We also hope to bring along a one of our campaigning volunteers to help with this. I was wondering if anyone would be able to pop downstairs to accept this box as we would love to get some pictures of us handing it in to share with our supporters. Do you know if there are special

photo permissions required for taking photographs near/of the DH building?

Please can you also confirm at what time on 10th the consultation will close? Will this be 5pm or midnight?
