Thank you for your email of 5 December 2013 where you requested the following information:

My FOI request concerns a written answer by Gregory Barker.

For each of the 13 private sector secondees to DECC who have had "limited input in drafting aspects of primary and secondary legislation", I would like to know which company each secondee came from and exactly what legislation that secondee worked on.

If it comes to light that other secondees among the 66 listed worked on legislation, I would like to know the same information about them too please.

Freedom of Information Act 2000

Your request has been handled under the Freedom of Information Act 2000 ('the Act'). Under the Act you have the right to:

- know whether we hold the information you have requested; and
- be provided with that information (subject to any exemptions under the Act which may apply).

The details of which organisation each of the secondees came from was provided in the written Parliamentary response but is reproduced again at <u>Appendix A</u> with those who have had the opportunity for limited input to aspects of preparing policy development at <u>Appendix B</u>.

DECC's in-house legal team instructs the Office of Parliamentary Counsel to draft primary legislation and is responsible for the drafting of its secondary legislation. Secondees to DECC have not been involved in drafting legislation or in providing any legal advice. DECC policy makers (including secondees) may undertake policy development work, provide policy instructions and comment on drafts. No secondee has been involved in drafting any legislation but some have been involved in preparatory policy work. Our central records do not contain details of any specific pieces of legislation on which secondees have worked; rather, DECC business managers have indicated that the secondees concerned would have had such opportunities.

Appeals procedure

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to the Information Rights Unit (foi@decc.gsi.gov.uk).
