FREEDOM OF INFORMATION REQUEST

Thank you for your email sent to the Scotland Office on 1 January 2014.

You asked for the following information under the Freedom of Information Act 2000:

- 1. Please provide figures for how many departmental staff have been issued with a) smart phones b) standard mobile phones c) tablet computers d) standard laptops in each of the past three financial years.*
- 2. How many of these smart phones have been reported as lost or stolen in each of the past three years.*
- 3. How many of these mobile phones have been reported as lost or stolen in each of the past three years.*
- 4. How many of these tablet computers have been reported as lost or stolen in each of the past three years.*
- 5. How many of these laptops have been reported as lost or stolen in each of the past three years.*

I am writing to confirm that the Scotland Office has now completed its search for information.

1. As at 31 March 2013 – (a) 35 members of staff had Blackberrys; (b) 3 members had standard mobile phones; (c) no members of staff were issued with tablet computers; (d) 37 members of staff had laptops provided in replacement to a desktop device.

As at 31 March 2012 – (a) 30 members of staff had Blackberrys; (b) 3 members of staff had standard mobile phones; (c) no members of staff were issued with tablet computers; (d) 21 members of staff had laptops provided in replacement to a desktop device.



As at 31 March 2011 – (a) 26 members of staff had Blackberrys; (b) 5 members of staff had standard mobile phones; (c) no members of staff were issued with tablet computers; (d) 18 members of staff had laptops provided in replacement to a desktop device..

2. In 2012/13 – 1 Blackberry handset was lost/stolen. In 2011/12 – 4 Blackberry handsets were lost/stolen. In 2010/11 – 1 Blackberry handset was lost/stolen.

3. No standard mobile phones were reported as lost/stolen over the same 3 year period.

5. No laptops were reported as lost/stolen over the same 3 year period.

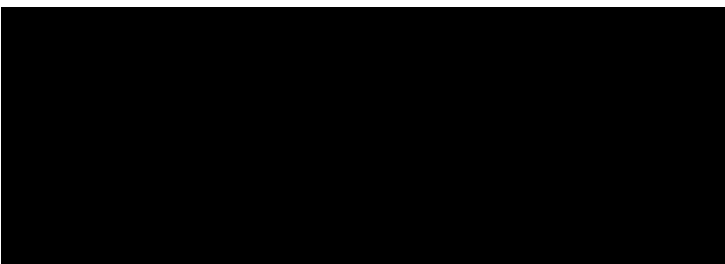
