Children at the border may be detained pending further examination and/or while awaiting onward transportation once a decision has been taken on their eligibility for entry to the UK or should an asylum claim have been made.

The Home Office cannot control the number of children who may be initially detained in such manner but strives to minimise the time spent in detention by prioritising these cases.
