Staff in Post by Job Group


Table 1 – Staff in Post by Job Group

- On 30th September 2013 there was a total of 16,299.99 FTE staff employed and funded by the Probation Service (including Chief Executives); an increase of 2.85 FTE on the figure at the end of Quarter 1 2013/14 (up 0.02%).
- When compared to Quarter 1 2013/14, 7 of the 15 job groups have shown an increase in staff in post, whilst 7 groups have decreased. The Psychologist job group remained the same.
- The largest increases were in the Probation Officer job group; increasing by 58.64 FTE (up 1.35%), and the Other Operational Staff job group, which increased by 37.78 FTE (up 3.97%).
- The largest decrease was in the Probation Services Officer job group; decreasing by 40.03 FTE (down 0.92%). The next largest decrease came in the Support Staff - Other job group which fell by 27.48 FTE (down 3.59%).
- The percentage of staff working in an offender related function at the end of Q2 was 88.74% (14,463.93 FTE), with 11.23% of staff working in Corporate Services (1,830.79 FTE). Those with a not recorded function accounted for 0.03% (5.27 FTE)
- The ratio of staff in offender services to corporate services was 7.90:1, up from 7.85:1 in Q1 13/14.
- The ratio of Probation Officers to Probation Services Officers was 1.03:1, up from 1.00:1 when compared to the previous guarter.
- The ratio of non-management to management staff was 8.61:1, up from 8.43:1 in the last quarter.
- Staff working in management roles accounted for 10.40% of the total workforce (1,695.78 FTE); a decrease from 10.61% in Q1; 89.60% of staff were in a non-management role (14,604.21 FTE) an increase from 89.39% in Q1.


Staff in Post by Function



- The job group with the largest number of staff working in an 'Offender Management' function in Quarter 2 2013/14 was the Probation Officer group with 3.794.01 FTE (85.96% of the group).
- The Probation Services Officer job group had the largest number of staff working in an 'Interventions' function with 1,471.83 FTE (34.22% of the group).
- The Probation Services Officer job group also had the largest number working in an 'Other Agency/Services' function with 430.42 FTE (10.01% of the group).
- The Support Staff Other job group had the largest number of staff working in a 'Corporate Services' function with 544.41 FTE (73.71% of the group).
- London region had the largest number of staff working in an 'Offender Management' function (1,502.26 FTE); whereas North West region had the largest number in an 'Interventions' function (543.41 FTE); West Midlands region had the largest number in an 'Other Agency/Services' function (205.09 FTE) and North West region had the largest number in a 'Corporate Services' function (246.90 FTE).

Chart 2 - Change in Staff in Post by Trust





- At the end of Quarter 2 2013/14, 22 of the 35 probation trusts reported a decrease in staff from the previous quarter (63%); whilst 13 reported an increase (37%).
- West Mercia reported the largest decrease in percentage terms when compared to the previous quarter, with a fall of 3.17% (9.34 FTE). The next largest decrease was in Thames Valley with a fall of 2.59% (13.57 FTE) respectively; followed by Northamptonshire who saw a fall of 1.82% (3.12 FTE).
- The largest quarterly FTE fall came in Staffordshire & West Midlands, with a drop of 20.29 FTE (1.33%); followed by Thames Valley and West Mercia, with falls of 13.57 FTE (2.59%) and 9.34 FTE (3.17%) respectively.
- Wiltshire and York & North Yorkshire reported the largest quarterly increases in percentage terms with increases of 7.75% (10.60 FTE) and 4.66% (8.68 FTE) respectively; followed by Warwickshire who saw an increase of 2.97% (3.80 FTE).
- The largest quarterly FTE increase came in Wales, with a rise of 24.54 FTE (2.52%); followed by London, with an increase of 14.27 FTE (0.67%). Following these, South Yorkshire was next with a rise of 13.89 FTE (2.87%).

- At the end of Quarter 2 2013/14, 6 of the 10 probation regions reported a decrease in staff from the previous quarter (60%); whilst 4 reported an increase (40%).
- West Midlands region reported the largest decreases in both percentage and FTE terms when compared to the previous quarter, with falls of 1.32% and 25.83 FTE respectively.
 The next largest decreases were in East of England region with falls of 1.15% and 16.54 FTE.
- Wales and Yorkshire & Humberside regions reported the largest quarterly increases in percentage terms with increases of 2.52% (24.54 FTE) and 2.08% (38.31 FTE) respectively.
- The largest quarterly FTE increase came in the Yorkshire & Humberside region, with a rise of 38.31 FTE (2.08%); followed by Wales, with an increase of 24.54 FTE (2.52%).

- At the end of Q2 2013/14, 6.30% of staff employed by the Probation Service were funded by external organisations (1,096.74 FTE).
- The largest group of staff employed by the probation trusts but funded by external organisations were those funded by HMPS; accounting for 608.25 FTE.
