Survey and research methodology

Survey of member recruitment and engagement within foundation trusts

- All 131 foundation trusts authorised as of 1 October 2010 were included in the survey universe.
- Fieldwork was conducted between 22 November 2010 31 January 2011.
- Those responding were representative of all foundation trusts as shown in the charts below.
- The survey was conducted online and respondents were sent an e-mail
 containing a link to the survey. Respondents were asked to write in their
 trust name so that any duplicate or invalid responses (for example from an
 unauthorised trust) could be deleted once the survey had closed.
- 115 responded; a response rate of 88%.

A number of steps were taken to achieve this response rate:

- Monitor e-mailed chairs on 19 November informing them that the survey would be taking place and that their trust secretary would receive the questionnaire unless otherwise instructed. A copy of the letter sent to chairs is available on request – please contact the Electoral Reform Research department on 0208 829 8412. The questionnaire can be found on Monitor's website.
- Trust secretaries were emailed instructions on how to access the online survey which were followed up with an email from the FTN.
- ERS sent a reminder to all foundation trusts who had not responded on 7
 December. This was followed up with an email from the FTN encouraging
 trusts to reply.
- Those with queries about the survey were asked to contact Monitor, the FTN or ERS.
- The questionnaire was pre-tested with two foundation trusts (South London and Maudsley and Chelsea and Westminster Hospital) on 5 and 8 November 2010.

Election database analysis


- The analysis covers 126 of the foundation trusts which were authorised as of 1 October 2010.
- Before starting the analysis, ERS identified all trusts for which it had no
 election data as another company had carried out their elections. These trusts
 were sent e-mails asking them to send their election data so their results
 could be included. There were 9 trusts (out of 131) for whom ERS did not hold
 the relevant data and 4 of these sent back details of their elections.
- Of the 2,978 elections included in this analysis 38 were carried out by an organisation other than ERS.
- 1,749 elections were contested.
- The database itself covers 142 trusts covering 3,127 elections but, for the purpose of this report, only elections at authorised foundation trusts were included.

Figure 1 Responding foundation trusts by authorisation date and trust type (trust figures as at 30 November 2010)







Figure 2 Responding foundation trusts by geographical region
