Reject	 DFID is already working with the Government of Montserrat (GoM) to agree investments which will maximise Montserrat's self-sufficiency and we will continue to do so. In our view developing a more detailed theoretical understanding of self-sufficiency at this point would be an unhelpful distraction from our current focus on investigating practical propositions. Financial self-sufficiency will be achieved when Montserrat can meet its reasonable needs sustainably without UK financial assistance. The UK and Montserrat governments are working together to identify a pathway to financial sustainability. This is set out, for example, in the 2012 Memorandum of Understanding (MoU), which details a coherent set of actions to increase private sector activity. 		
Recommendation 2: DFID should support the Government of Montserrat to develop a longer-term plan for Montserrat based on the agreed understanding of self-sufficiency. This needs to show how the different projects add up to a coherent impact on livelihoods and economic progress. It should set out the	Reject	 We are already working with the GoM on a longer term plan to maximise self-sufficiency rather than assuming 100 per cent self-sufficiency is feasible. DFID supports the GoM's own strategies, as set out, for example, in the UK Government's White Paper (2012). With the GoM, we have identified and are currently appraising a package of strategic projects aimed at identifying economically and financially justifiable UK-financed investments that could lead to the elimination of UK budget aid. Without investments such as these, self-sufficiency will not be attainable and devising a plan to achieve it would not be a good

Within these planning laws, we have involved the people of Montserrat in our projects, for example: Building an extensive community outreach programme into the Lookout School expansion project. Holding a series of roundtable discussions on geothermal development. Ensuring the GoM integrates social impact into planning (e.g. new port/town developments, the physical development plan); Engaging the political opposition and the media in budgetary aid missions – DFID increased its budget aid this year to fund an office for the opposition to facilitate their engagement in local social and economic developments; Involving the private sector in the assessment of progress on the MoU; Involving educational institutions, staff and students in assessing progress in the education sector. Reject	 DFID is already working closely with the FCO and other UK Government departments to deliver the White Paper commitments in Montserrat and other OTs. All UK Government Departments now support the Overseas Territories in their own areas of competence and expertise and have written papers that set out how they will do this. For Montserrat specifically: UKTI (Barbados) provides advice on exporting and inward investment, and promotes investment opportunities in Montserrat to UK businesses. DFID is exploring with the Department for Education the support they can offer. In other OTs there are many examples of cross-Whitehall support, such as: The Ministry of Defence, the Department of Business, Innovation and Skills and HMRC seconded staff to the Turks and Caicos Islands (TCI) in 2010 and 2011; Norfolk County Council has been assisting senior civil servants in the TCI; School linkages and teacher exchanges between Shropshire Council and St Helena have been created with the help of the Department of Education. The FCO is organising a Business Forum involving the OTs later this year. DFID is cofinancing, with DEFRA and the FCO, Darwin Plus (worth £2m annually), to improve
