FREEDOM OF INFORMATION ACT 2000

I refer to your letter of 26 April 2011. We have dealt with your request under the terms of the Freedom of Information Act 2000.

The Act gives a period of 20 working days for response by the public authority holding the information. This means that the period available to VOSA for dealing with you request is between the dates of 27 April, the date on which the letter was received, and 27 May 2011as the final date on which a response could be issued.

I have looked through the attachments to your letter and confirm that a check has been carried out in respect of received postal correspondence on site and no trace was found of your initial letter dated 4 April 2011. However had this letter been received, the 20 working day period for response ends on 9 May 2011.

This morning a check has also been made on the web address given in (name removed) letter of 28 March and I am able to confirm that the relevant page is active and the documents are available from that location.

As you are aware Section 21 of the Freedom of Information Act does not require information to be provided to you where it is already reasonably accessible. However due to the apparent difficulties in accessing this information, documented in your letter, I have enclosed a print of the downloaded documents GV 74 and PSV 437 - 02 for your use.

I have spoken to a colleague in respect of the urban bus network which is controlled by Transport for London, she has advised that VOSA has no input to matters under TfL's control and no information is held by VOSA in regard to your request.

The Information Commissioner can consider complaints about any aspect of the way in which requests for information have been handled. Please note: the Information Commissioner would be unlikely to consider your complaint if you have not first requested an internal review.
