- 2) Please state how many individuals from external organisations are currently on secondment within DECC. For each secondee please state the name of their home organisation.
- 3) For each secondee from the oil and gas industry please provide the following information:
  - I. The position of the secondee at DECC
  - I. The company that the secondee is from
  - II. The duration of the secondment, including the start date and end date of the secondment
- III. The DECC policy team they are currently working at
- IV. The position of the DECC official to whom the secondee reports to
