# Chairman's Foreword

These results for 2012 complete the departmental performance data first published in the Regulatory Policy Committee's (RPC) fifth report, *Assessing Regulation*, in November 2012.

As set out in this report, the RPC continues to provide the Government with balanced, independent Opinions on the impact assessments within its scope, and scrutinises the estimated net costs to business of all regulatory measures that

feature in the Government's Statements of New Regulation.

The period covered by our last report pre-dated the introduction of the new fast track system. The fast track system is designed for all deregulatory proposals and those proposals with a low cost to business and civil society organisations. Under this system, we still validate the net cost to business and civil society organisations of all measures that fall within the scope of the One-in, Two-out policy. The purpose of publishing the full departmental results for 2012 is to provide complete data for that year, including reporting on the initial bedding-in period for the fast track system.

At the same time as publishing these results, we are also - for the first time - making publicly available in a single place, the Opinions issued by the Committee in 2012, where these relate to impact assessments for proposals which have been taken forward by the Government. I believe an important next step in enhancing the impact of independent scrutiny is providing access to the Committee's Opinions, at a meaningful time such as during consultations, and for the future we are exploring how to ensure our Opinions are publicly available as early as possible.

As the results for 2012 show, there has been a significant improvement in the quality of impact assessments produced by departments. In 2012 81% of main Opinions were rated 'fit for purpose', compared to 56% in 2010. We believe that our independent scrutiny has played a significant part in driving this improvement. However, while there has been an improvement in the proportion of impact assessments rated 'fit for purpose', there is a disappointingly low proportion where we have no significant concerns; there remains clear room for further improvement. We take the view that high quality impact assessments can support effective engagement and steer regulatory policy decision making, and we believe it is vital that the quality of impact assessments continues to improve to enable them to be used effectively.


I hope you will find this report and our published Opinions interesting and informative, and would welcome any views that you may have.

## Final 2012 Departmental Results

In our report Assessing Regulation<sup>1</sup> tables 2.1 and 2.2 provided information on departmental performance in the months January -August 2012. We have now updated those figures to include departmental performance from August - December 2012 and also to report on the first few months of the fast track system (covering deregulatory and low cost proposals) which began operation in August 2012.


# Headline results

- 1. In 2012 we issued 654 Opinions up from 579 in 2011.
- 2. Of these, 533 were on first time submission, covering 443 full impact assessments and 90 fast track Regulatory Triage Assessments.
- 3. As set out in *Assessing Regulation*, first time submissions are an appropriate focus for reporting of departmental performance as they represent what departments produced using their internal systems without RPC comments.
- 4. Overall the proportion of 'fit for purpose' Opinions rose from 72% in 2011 to 81% in 2012 for main Opinions. For fast track Regulatory Triage Confirmations 89% were deemed 'fit for purpose' and eligible for the fast track during the introductory period August December 2012.

## The New System

#### Full scrutiny

- 5. The system for RPC scrutiny of impact assessments (IAs) has been streamlined (Chapter 3, *Assessing Regulation*). The streamlined process has led to changes in how the RPC rates its final stage Opinions. These Opinions cover those proposals, including major regulatory proposals (with over £1m gross annual cost to business and civil society organisations) which require full scrutiny, EU 'gold-plating', and other impact assessments where a department has voluntarily chosen to take this route.
- 6. Full IAs are submitted to the RPC for scrutiny at consultation and final stages. At consultation stage, an RPC Opinion is rated as a 'Red', 'Amber' or 'Green' depending on the fitness for purpose of the IA, based on our seven recommendations (Chapter 1, *Assessing Regulation*). For final stage IAs, our Opinions for August to December 2012 included a rating of 'Red' or 'Green' based solely on the validity of their One-in, One-out assessment. Final stage Opinions may, however, include comments on other aspects of the IA, which the department is expected to address.

### Impact Assessments: Departmental Rankings – 2012 (Table 1)

First time submissions

#### **Fast track**

- 7. The proposals covered by the fast track system are deregulatory, including those identified through the Red Tape Challenge, as well as any regulatory proposals with a total gross cost to business and civil society organisations that is below £1m per annum. A proposal is defined as deregulatory if it reduces the scope of government regulation or removes government controls from business or civil society organisations.
- 8. *Consultation stage*: for deregulatory and low cost proposals, the department can submit to the RPC a 'Regulatory Triage Assessment' (RTA) rather than a full impact assessment. In response, the RPC issues a 'Regulatory Triage Confirmation' (RTC), which confirms whether or not the proposal is eligible for the fast track route and whether the proposal is within the scope of the One-in, Two-out (OITO) policy. Proposals that have been approved by the Reducing Regulation Committee (RRC) as part of a conclusion to a Red Tape Challenge theme are deemed suitable for the fast track route without the need to be submitted to the RPC at consultation stage.
- 9. Our fast track RTCs focus on whether proposals are eligible for the fast track. As such RTCs are based on an assessment of whether the information provided enables us to confirm that the proposal is likely to be deregulatory or a low-cost regulatory measure. RTCs either confirm the proposal is eligible under one of these categories ('Green') or that it is not possible to confirm the triage assessment based on the information provided ('Red').
- 10. *Final stage*: if a proposal is in scope of OITO, and has been confirmed by the RPC as eligible for the fast track process or is a Red Tape Challenge proposal, then either a full IA, or simplified validation IA, setting out the estimated Equivalent Annual Net Cost to Business (EANCB) figure must be submitted to the RPC. IAs at this stage should provide supporting evidence for the estimated impacts on business and civil society organisations. In response the RPC issues a confirmation of whether the proposal is correctly identified as being an 'IN', 'OUT' or 'out of scope' of OITO, and on the validity of the estimated EANCB figure.
- 11. For fast track proposals, the performance for the August to December 2012 period will not be comparable to future reporting, as we allowed departments a period of adjustment to the 31 December 2012 to enable the new system to mature. As such, in some cases departmental performance may appear stronger during this period than is actually the case.

#### **Opinions issued by the Regulatory Policy Committee in 2012**

Detailed below is a list of all IAs on which RPC Opinions were issued during 2012 with the accompanying 'Red, Amber or Green' rating. Some regulatory measures appear twice in this list, which indicates that we issued an Opinion at both the consultation and final stage.

Of the IAs that were scrutinised during this period, we have not published details on a small number, as these have not yet been publicly announced and have therefore been treated as confidential as requested by departments.

There are a number of measures where no 'fit for purpose' rating from the RPC has been shown. Possible reasons for this are:

- A department has proceeded without a 'fit for purpose' rating in such instances we publish our Opinions and they can be found on our website;
- A department has decided to withdraw a regulatory proposal so no clearance from the Reducing Regulation Committee is required;
- A submission of a revised IA was not received during 2012;
- A submission of a revised IA has been received but we had not issued an Opinion by 31 December 2012.

As such, a small number of measures will have subsequently received fit for purpose ratings which are not reflected within the 2012 Opinions.

Opinions marked \* indicate that earlier submissions of these IAs also received an Opinion before January 1 2012, details of which are not included here.
