## <sup>1</sup>STATEMENT OF CHANGES IN IMMIGRATION RULES

The Home Secretary has made the changes hereinafter stated in the rules laid down by her as to the practice to be followed in the administration of the Immigration Acts for regulating entry into and the stay of persons in the United Kingdom and contained in the statement laid before Parliament on 23 May 1994 (HC 395) as amended. # Implementation

The changes set out in this statement shall take effect on 1 July 2013. However, with regard to the changes set out in paragraphs 22, 36 and 39 of this Statement only, if an applicant has made an application for entry clearance or leave using a Certificate of Sponsorship that was assigned to him by his Sponsor before 1 July 2013, the application will be decided in accordance with the Rules in force on 30 June 2013.

# Review

Before the end of each review period, the Secretary of State undertakes to review all of the relevant Immigration Rules, including any Relevant Rule amended or added by these changes. The Secretary of State will set out the conclusions of the review in a report and publish the report.

The report must in particular:

- (a) consider each of the Relevant Rules and whether or not each Relevant Rule achieves its objectives and is still appropriate; and
- (b) assess whether those objectives remain appropriate and, if so, the extent to which they could be achieved with a system that imposes less regulation.

"Review period" means:

- (a) the period of five years beginning on 6 April 2012, and
- (b) subject to the paragraph below, each successive period of five years.

If a report under this provision is published before the last day of the review period to which it relates, the following review period is to begin with the day on which that report is published.

"Relevant Rule" means an immigration rule which imposes a net burden (or cost) on business or civil society organisations.

## Changes

- In paragraph 6, in the definition of "relevant NHS body" after "of these Rules" insert ", and in paragraphs S-EC.2.3., S-LTR.2.3. and S-ILR.2.3. of Appendix FM to these Rules".
- 2. In paragraph 245GE(h)(ii), delete "£150,000" and substitute "£152,100".
- 3. In paragraph 245ZR(b)(ii)(3), after "a Contractual Service Supplier", insert "or Independent Professional".
- 4. Delete paragraph 245ZV(ga)(iii)(4) and substitute:

"(4) Law, where the applicant has completed a course at degree level in the UK and is progressing to:

a. a law conversion course validated by the Joint Academic Stage Board in England and Wales, a Masters in Legal Science (MLegSc) in Northern Ireland, or an accelerated graduate LLB in Scotland; or
b. the Legal Practice Course in England and Wales, the Solicitors Course in Northern Ireland, or a Diploma in Professional Legal Practice in Scotland; or
c. the Bar Professional Training Course in England and Wales, or the Bar Course in Northern Ireland."

5. Delete paragraph 245ZX(ha)(iii)(4) and substitute:

"(4) Law, where the applicant has completed a course at degree level in the UK and is progressing to:

a. a law conversion course validated by the Joint Academic Stage Board in England and Wales, a Masters in Legal Science (MLegSc) in Northern Ireland, or an accelerated graduate LLB in Scotland; or
b. the Legal Practice Course in England and Wales, the Solicitors Course in Northern Ireland, or a Diploma in Professional Legal Practice in Scotland; or
c. the Bar Professional Training Course in England and Wales, or the Bar Course in Northern Ireland."

6. After paragraph 245ZY(ba) insert:

"(bb) Leave to remain as a Tier 4 (General) Student on the doctorate extension scheme will not be subject to the conditions on the limited time that can be spent as a Tier 4 (General) Student or as a student, specified at 245ZX (hb)."

- 7. Delete paragraph 245ZY(c)(v)(4)
- 8. After paragraph 245ZY(c)(iv)(3) insert:

"(4) study at the same or a higher level of course as that stated on the confirmation of acceptance for studies, or at a lower level where the same requirements or conditions of leave would have applied if the application had been to study at that lower level."

- 9. In paragraph 284(i) after "has" insert "or was last granted".
- 10. In paragraph 284(ii) before "is married" insert "the applicant".
- 11. In paragraph 295D(i) after "has" insert "or was last granted".
- 12. In paragraph 301(vi) delete "or, if seeking leave to remain, was admitted with a valid United Kingdom entry clearance for entry in this category".
- 13. Delete paragraph 319C(i) and substitute:

- "(i) Where the relevant Points Based System Migrant is applying for, or has been granted, entry clearance, leave to enter, or leave to remain in the United Kingdom as a Tier 4 (General) Student either:
  - (i) the relevant Points Based System Migrant must be a government sponsored student who is applying for, or who has been granted, entry clearance or leave to remain to undertake a course of study longer than six months;
  - (ii) the relevant Points Based System Migrant must:
    - (1) be applying for, or have been granted entry clearance or leave to remain in order to undertake a course of study at post-graduate level longer than 12 months; and
    - (2) be sponsored by a sponsor who is a Recognised Body or a body in receipt of funding as a higher education institution from either:
      - (a) the Department for Employment and Learning in Northern Ireland;
      - (b) the Higher Education Funding Council for England;
      - (c) the Higher Education Funding Council for Wales; or
      - (d) the Scottish Funding Council;
  - (iii) the relevant Points Based System Migrant must be applying for, or have been granted leave to remain as a Tier 4 (General) Student on the doctorate extension scheme; or
  - (iv) the following conditions must be met:
    - (1) the relevant Points Based System Migrant must be applying for entry clearance, leave to enter, or leave to remain, to undertake a course of study that is longer than six months and either:
      - (a) have entry clearance, leave to enter, or leave to remain as a Tier 4 (General) Student or as a student to undertake a course of study longer than six months; or
      - (b) have last had entry clearance, leave to enter, or leave to remain within the three months preceding the application as a Tier 4 (General) Student or as a student to undertake a course of study longer than six months; and
    - (2) the Partner must either:

- (a) have entry clearance, leave to enter, or leave to remain as the Partner of a Tier 4 (General) Student or a student with entry clearance, leave to enter, or leave to remain, to undertake a course of study longer than six months; or
- (b) have last had entry clearance, leave to enter, or leave to remain within the three months preceding the application as the Partner of a Tier 4 (General) Student or as a student to undertake a course of study longer than six months; and
- (3) the relevant Points Based System Migrant and the Partner must be applying at the same time."
- 14. Delete paragraph 319H(i) and substitute:
  - "(i) Where the relevant Points Based System Migrant is applying for, or has been granted, entry clearance, leave to enter, or leave to remain in the United Kingdom as a Tier 4 (General) Student either:
    - (i) the relevant Points Based System Migrant must be a government sponsored student who is applying for, or who has been granted, entry clearance or leave to remain to undertake a course of study longer than six months;
    - (ii) the relevant Points Based System Migrant must:
      - be applying for, or have been granted entry clearance or leave to remain in order to undertake a course of study at post-graduate level longer than 12 months; and
      - (2) be sponsored by a sponsor who is a Recognised Body or a body in receipt of funding as a higher education institution from either:
        - (a) the Department for Employment and Learning in Northern Ireland;
        - (b) the Higher Education Funding Council for England;
        - (c) the Higher Education Funding Council for Wales; or
        - (d) the Scottish Funding Council;
    - (iii) the relevant Points Based System Migrant must be applying for, or have been granted leave to remain as a Tier 4 (General) Student on the doctorate extension scheme; or
    - (iv) the following conditions must be met:

- the relevant Points Based System Migrant must be applying for entry clearance, leave to enter, or leave to remain, to undertake a course of study that is longer than six months and either:
  - (a) have entry clearance, leave to enter, or leave to remain as a Tier 4 (General) Student or as a student to undertake a course of study longer than six months; or
  - (b) have last had entry clearance, leave to enter, or leave to remain within the three months preceding the application as a Tier 4 (General) Student or as a student to undertake a course of study longer than six months; and
- (2) the Child must either:
  - (a) have entry clearance, leave to enter, or leave to remain as the Child of a Tier 4 (General) Student or a student with entry clearance, leave to enter, or leave to remain, to undertake a course of study longer than six months; or
  - (b) have last had entry clearance, leave to enter, or leave to remain within the three months preceding the application as the Child of a Tier 4 (General) Student or as a student to undertake a course of study longer than six months; and
- (3) the relevant Points Based System Migrant and the Child must be applying at the same time."
- 15. In Appendix A, in the first row of Table 4, in paragraph (b)(i), delete "regulated by the Financial Services Authority" and substitute "regulated by the Financial Conduct Authority (FCA)".
- 16. In Appendix A, in paragraph 41-SD(a)(i)(11), delete "regulated by the FSA" and substitute "regulated by the Financial Conduct Authority (FCA) and the Prudential Regulation Authority (PRA)".
- 17. In Appendix A, in paragraph 41-SD(a)(ii)(2), delete "regulated by the Financial Services Authority" and substitute "regulated by the Financial Conduct Authority (FCA) and the Prudential Regulation Authority (PRA)".
- 18. In Appendix A, delete paragraph 41-SD(b)(i)(6) and substitute:
  - "(6) if the third party is a venture capitalist firm, confirmation of whether this body is regulated by the Financial Conduct Authority (FCA) and is listed as permitted to operate as a Venture Capital firm,"

- 19. In Appendix A, in paragraph 64-SD(a)(ii), delete "regulated by the Financial Services Authority" and substitute "regulated by the Financial Conduct Authority (FCA) (and the Prudential Regulation Authority (PRA) where applicable)".
- 20. In Appendix A, in paragraph 65-SD(a)(viii), delete "regulated by the Financial Services Authority" and substitute "regulated by the Financial Conduct Authority (FCA) (and the Prudential Regulation Authority (PRA) where applicable)".
- 21. In Appendix A, in paragraph 65-SD(b), delete "regulated by the Financial Services Authority" and substitute "regulated by the Financial Conduct Authority (FCA) (and the Prudential Regulation Authority (PRA) where applicable)".
- 22. In Appendix A, delete paragraph 78C(b) and substitute:
  - "(b) the job offer must be in a supernumerary research position where the applicant has been issued a non-transferable scientific research Award or Fellowship by an external organisation which is not the Sponsor, meaning that the role is over and above the Sponsor's normal requirements and if the applicant was not there, the role would not be filled by anyone else; or"
- 23. In Appendix A, delete paragraph 92A and substitute:
  - "92A. To confirm that the Resident Labour Market Test has been passed or the role is exempt from the test, and for points to be awarded, the Certificate of Sponsorship Checking Service entry must confirm:
    - (a) That the role is supernumerary, such that it is over and above the Sponsor's normal staffing requirements and if the person filling the role was not there, it would not need to be filled by anyone else, with a full explanation of why it is supernumerary; or
    - (b) That the role involves living mainly within and being a member of a religious order, which must be a lineage of communities or of people who live in some way set apart from society in accordance with their specific religious devotion, for example an order of nuns or monks; or
    - (c) That the Sponsor holds national records of all available individuals, details of those records and confirmation that the records show that no suitable settled worker is available to fill the role; or
    - (d) That a national recruitment search was undertaken, including the following details:
      - (i) Where the role was advertised, which must be at least one of the following:
        - (1) a national form of media appropriate to the Sponsor's religion or denomination,

- (2) the Sponsor's own website, if that is how the Sponsor usually reaches out to its community on a national scale, that is where it normally advertises vacant positions, and the pages containing the advertisement are free to view without paying a subscription fee or making a donation, or
- Jobcentre Plus (or in Northern Ireland, JobCentre
   Online) or in the employment section of a national newspaper, if there is no suitable national form of media appropriate to the Sponsor's religion or denomination;
- (ii) any reference numbers of the advertisements;
- (iii) the period the role was advertised for, which must include at least 28 days during the 6 month period immediately before the date the Sponsor assigned the Certificate of Sponsorship to the applicant; and
- (iv) confirmation that no suitable settled workers are available to be recruited for the role;

or the applicant must be applying for leave to remain and the Sponsor must be the same Sponsor as in his last grant of leave."

- 24. In Appendix A, delete paragraph 111(d)(vi) and substitute:
  - "(vi) details of how the resident labour market test has been complied with or why the role is exempt from the test, as set out in paragraph 92A of this Appendix."
- 25. In Appendix A, delete paragraph 118(b)(ii)(4) and substitute:
  - "(4) the applicant provides the specified documents from an English language test provider approved by the Secretary of State for these purposes as listed in Appendix O, which clearly show:
    - i. the applicant's name,
    - that the applicant has achieved or exceeded level B2 of the Council of Europe's Common European Framework for Language learning in all four components (reading, writing, speaking and listening), unless exempted from sitting a component on the basis of the applicant's disability,
    - iii. the date of the award, and
    - iv. that the test is within its validity date (where applicable)."
- 26. In Appendix A, delete paragraph 118(b)(iii)(4) and substitute:

- "(4) the applicant provides the specified documents from an English language test provider approved by the Secretary of State for these purposes as listed in Appendix O, which clearly show:
  - i. the applicant's name,
  - that the applicant has achieved or exceeded level B1 of the Council of Europe's Common European Framework for Language learning in all four components (reading, writing, speaking and listening), unless exempted from sitting a component on the basis of the applicant's disability,
  - iii. the date of the award, and
  - iv. that the test is within its validity date (where applicable)."
- 27. In Appendix A, delete paragraph 120-SD(a) and substitute:

"(a) In the case of evidence relating to previous qualifications, the applicant must provide, for each qualification, either:

- (i) The original certificate(s) of qualification, which clearly shows:
  - (1) the applicant's name,
  - (2) the title of the award,
  - (3) the date of the award, and
  - (4) the name of the awarding institution;

(ii) The transcript of results, which clearly shows:

- (1) the applicant's name,
- (2) the name of the academic institution,
- (3) their course title, and
- (4) confirmation of the award;

This transcript must be original unless the applicant has applied for their course through UCAS (Universities and Colleges Admissions Service), and:

(a) the applicant is applying in the UK to study at a Higher Education Institution which has Highly Trusted Sponsor status, and

(b) the qualification is issued by a UK awarding body for a course that the applicant has studied in the UK;

#### or

(iii) If the applicant's Tier 4 sponsor has assessed the applicant by using one or more references, and the Confirmation of Acceptance for Studies Checking Service entry includes details of the references assessed, the original reference(s) (or a copy, together with an original letter from the Tier 4 sponsor confirming it is a true copy of the reference they assessed), which must contain:

(1) the applicant's name,

(2) confirmation of the type and level of course or previous experience; and dates of study or previous experience,

- (3) date of the letter, and
- (4) contact details of the referee."
- 28. In Appendix B, delete paragraph 10 and substitute:

# "Passed an English language test

- 10. 10 points will only be awarded for passing an English language test if the applicant has the relevant level of English language shown in Table 1 and provides the specified documents from an English language test provider approved by the Secretary of State for these purposes, as listed in Appendix O, which clearly show:
  - (1) the applicant's name,
  - the qualification obtained, which must meet or exceed the relevant level shown in Table 1 in all four components (reading, writing, speaking and listening), unless the applicant was exempted from sitting a component on the basis of his disability,
  - (3) the date of the award, and
  - (4) that the test is within its validity date (where applicable)."
- 29. In Appendix C, in paragraph 1B(c), delete "regulated by the Financial Services Authority" and substitute "regulated for the purpose of personal savings accounts by the Financial Conduct Authority (FCA) and the Prudential Regulation Authority (PRA)".
- 30. In Appendix C, in paragraph 1B(d), delete "regulated by either the Financial Services Authority" and substitute "regulated for the purpose of student loans by either the Financial Conduct Authority (FCA) and the Prudential Regulation Authority (PRA)".
- 31. In Appendix FM-SE, in paragraph 1(aa) delete "the Financial Services Authority" and substitute "the Financial Conduct Authority and the Prudential Regulation Authority".

# EXPLANATORY MEMORANDUM TO THE STATEMENT OF CHANGES IN IMMIGRATION RULES PRESENTED TO PARLIAMENT ON 10 JUNE 2013 (HC 244)

1. This explanatory memorandum has been prepared by the Home Office and is laid before Parliament by Command of Her Majesty.

# 2. Purpose of the Instrument

- 2.1. The purpose of these changes is to:
  - make minor updates and corrections to the Points-Based System and to the family Immigration Rules; and
  - incorporate compulsory screening for active pulmonary tuberculosis for migrants coming to the UK for over six months from additional specified countries and add an authorised screening clinic in Cote d'Ivoire.

# **3.** Matters of special interest to the Joint Committee on Statutory Instruments or the Select Committee on Statutory Instruments

3.1. The Committee is invited to note that this Statement of Changes is accompanied by amended guidance which is being published on the Home Office website at <a href="http://www.ukba.homeoffice.gov.uk">www.ukba.homeoffice.gov.uk</a> on the same date as these changes are laid before Parliament, namely 10 June 2013.

3.2. This Statement increases the number of countries in which pre-entry tuberculosis screening is required and increases the number of clinics authorised to carry out this screening in accordance with this policy. Following the previous Statement of Changes laid on 9 April 2013 (Cm 8599), the Secondary Legislation Scrutiny Committee was advised of the scope of the project and the planned frequency of further changes.

# 4. Legislative Context

4.1. The Immigration Rules, as laid before Parliament by the Home Secretary, constitute a statement of practice to be followed in the administration of the Immigration Act 1971 for regulating entry into and the stay of persons in the United Kingdom.

4.2. This Statement of Changes in Immigration Rules will be incorporated into a consolidated version of the Immigration Rules, which can be found under the 'Policy and Law' page at <u>www.ukba.homeoffice.gov.uk</u> where there are also copies of all the Statements of Changes in Immigration Rules issued since May 2003.

4.3. The changes set out in this statement shall apply to decisions made on or after 1 July 2013. However, with regard to the changes set out in paragraphs 22, 36 and 39 of this Statement only, if an applicant has made an applications for entry clearance or leave using a Certificate of Sponsorship that was assigned to him by his Sponsor before 1 July 2013, the application will be decided in accordance with the Rules in force on 30 June 2013.

# 5. Territorial Extent and Application

5.1. This instrument applies to all of the United Kingdom.

# 6. European Convention on Human Rights

6.1. As this Statement of Changes in Immigration Rules is subject to a negative resolution procedure and does not amend primary legislation, no statement is required.

# 7. Policy Background

# What is being done and why

7.1. A summary of the changes contained in this Statement follows:

# Changes relating to the Points-Based System

7.2. The rules for dependants of Tier 4 (General) Students and students are being restructured to ensure they clearly reflect the established policy and practice.

7.3. Changes are being made to the Resident Labour Market Test for the Tier 2 (Minister of Religion) category and the Religious Workers sub-category of Tier 5 (Temporary Worker). These set out that roles are exempt from the test where they involve living mainly within and being a member of a religious order, for example an order of nuns or monks. The changes also confirm that a Resident Labour Market Test is not required for extension applications with the same Sponsor.

7.4. The evidential requirements in relation to approved English language tests are being updated, to reflect changes in the documents issued by test providers.

7.5. An update is being made to the list of legal courses that are exempt from the Tier 4 time limit on study, ensuring that specified equivalent courses available in Scotland and Northern Ireland are listed.

7.6. Further updates are being made to the lists of financial institutions in Bangladesh and Ghana from which documents can be verified, and are therefore accepted for Points-Based System applications.

7.7. References to the Financial Services Authority (FSA) are being updated to reflect its replacement by two new regulators, the Financial Conduct Authority (FCA) and the Prudential Regulation Authority (PRA).

7.8. A clarification is being made to the Rules regarding maintenance funds, to confirm that where the Rules refer to regulated financial institutions, this refers to institutions regulated for the purpose of personal savings accounts and/or student loans (as appropriate), not institutions which are only regulated for other, irrelevant purposes. Although the Home Office has successfully defended legal challenges brought on this point, this clarification is being made to reduce the likelihood of further challenges being brought.

7.9. The following minor corrections are being made to changes implemented by HC 1039 (laid before Parliament on 14 March 2013):

- HC 1039 uplifted the £150,000 salary threshold, which applies to some provisions for senior staff in Tier 2, to £152,100 in line with wage inflation. One reference to £150,000 in the Rules was missed and this is now being updated.
- A slight adjustment is being made to the Resident Labour Market Test exemption for supernumerary researchers in the Tier 2 (General) category, to clarify that the scientific research Award or Fellowship awarded to the applicant must be nontransferrable and have been awarded by an external organisation which is not the Sponsor.
- The Codes of Practice set out (among other things) appropriate salary rates for skilled workers. A correction is being made to a typographical error in the "experienced worker" rate for accountants, to change it from £23,600 to £26,300.
- A correction is being made to the table showing equivalent occupations under the previous Standard Occupational Classification (SOC) 2000 system and the replacement SOC 2010 system. An equivalent occupation for marketing / sales managers was previously omitted and is now being included.
- Corrections are being made to the entries on the Shortage Occupation List for musicians (to add sub-principals and numbered string positions to the jobs included on the list, as recommended by the Migration Advisory Committee in its February 2013 report) and engineer / inspection technicians (to correct the occupation code used).
- A missing reference to independent professionals applying under the International Agreement sub-category of Tier 5 (Temporary Worker) is being added.

7.10. Transitional provisions ensure that the above corrections do not disadvantage any applicant who applies using a Certificate of Sponsorship that was assigned to him by his Sponsor before 1 July 2013.

7.11. The following further minor corrections are being made:

- The Rules currently require Tier 4 and Tier 5 Sponsors to apply for a Sponsor licence using the specified online form. This is being corrected to include Tier 2 Sponsors as well.
- Missing details are being added of the Cabinet Office Interchange Programme, which operates under the Government Authorised Exchange sub-category of Tier 5 (Temporary Workers).

# Changes relating to the family Immigration Rules

7.12. References in Appendix FM-SE to the Financial Services Authority (FSA) are being updated to reflect its replacement by two new regulators, the Financial Conduct Authority (FCA) and the Prudential Regulation Authority (PRA).

7.13. The following minor changes to Appendix FM-SE are being made in respect of the operation of the financial requirements for applications from partners and dependent children under Appendix FM:

- Allowing a pension paid by another government department or agency to be counted in the same way as the State pension paid by the Department for Work and Pensions.
- Counting cash savings in a pension savings account held by the applicant or their sponsor, whatever their age.
- 7.14. The following clarifications and corrections are being made:
  - Amending the pre-9 July 2012 routes under Part 8 for a spouse, civil partner, unmarried partner or same-sex partner to make clear that those pre-9 July 2012 applicants who can still access those routes can do so if they have overstayed by no more than 28 days.
  - Adding a missing reference to "the applicant" in the Part 8 rule for leave to remain as a spouse or civil partner.
  - Clarifying that the Part 8 route available in pre-9 July 2012 cases for limited leave with a view to settlement for a child of a parent(s) with limited leave with a view to settlement can be accessed by a child with leave to remain who entered the UK by a different route, e.g. as a student.
  - Applying the definition of "relevant NHS body" to the suitability provisions under Appendix FM which allow the applicant to be refused if they have failed to pay NHS charges of at least £1,000.

## Changes relating to tuberculosis screening

7.15. The UK has had a longstanding policy of screening new entrants from high incidence tuberculosis countries intending to remain for over six months. Screening has been conducted at ports of entry and, since October 2005, pre-entry in some high incidence tuberculosis countries. On 21 May 2012 the Government announced its intention to expand upon the pre-entry screening programme to allow for more extensive screening. Entry clearance applicants intending to come to the UK for over six months from countries where pre-entry screening is available will be required to present a certificate from a designated screening provider confirming that screening has been conducted and that the applicant has been diagnosed as free from active pulmonary tuberculosis. Where tuberculosis is detected, the applicant will be

required to undertake treatment and further screening before any entry clearance application can be made.

7.16. This Statement amends the previous Statement of Changes (HC 8599) in relation to compulsory screening for active pulmonary tuberculosis of migrants coming to the UK for more than six months from specified countries and required persons applying as fiancé(e)s from those countries to undergo screening. This Statement adds China (settlement cases only), Cameroon, Ethiopia, Gambia, Hong Kong (settlement cases only), Indonesia, Macau (settlement cases only), Malawi, Morocco, Sierra Leone, Uganda, Vietnam and Zambia to the specified countries and names the authorised clinic in these countries. It also adds an authorised screening clinic in Cote d'Ivoire.

7.17. These changes reflect a Government commitment to introduce pre-entry screening for tuberculosis in 82 countries. The relevant Written Ministerial Statement (WMS) of the then Minister of State for Immigration, Damian Green, of 21 May 2012 is at <a href="https://www.ukba.homeoffice.gov.uk/sitecontent/newsarticles/2012/may/42-tb-test">www.ukba.homeoffice.gov.uk/sitecontent/newsarticles/2012/may/42-tb-test</a>.

7.18. Operationally, we are ensuring alignment with Five Country Conference (FCC) partners who have been supporting the UK in implementing this programme and also the International Organisation for Migration (IOM) who are providing screening facilities in some countries.

# 8. Consultation

8.1. As these changes are limited to minor updates, clarifications and corrections, they have not been the subject of a formal public consultation.

# 9. Guidance

9.1. Where necessary, guidance will be updated and placed on the Home Office website <u>www.ukba.homeoffice.gov.uk</u> and regional Foreign and Commonwealth Office websites.

## 10. Impact

10.1. These changes will have limited or no impact on business, charities, the public sector or voluntary bodies, such that an impact assessment is unnecessary.

## 11. Regulating small business

11.1. The changes to Tier 2 of the Points-Based System will apply to small businesses that are Tier 2 Sponsors.

# 12. Monitoring and review

12.1. The review clauses at the beginning of this Statement of Changes require the Secretary of State to review the operation and effect of all of the relevant Immigration Rules, including any Rules amended or added by the changes in this Statement and lay a report before Parliament within five years of 6 April 2012 and within every five years after that.

Following each review the Secretary of State will decide whether the relevant Immigration Rules should remain as they are, be revoked or be amended. A further Statement of Changes would be needed to revoke or amend the relevant Rules.
