Report of the Proceedings of the Agricultural Wages Board for the Two Years Ended 31 December 2005

Constitution

1. The Agricultural Wages Board for Northern Ireland (the "Board") is constituted under the Agricultural Wages (Regulation) (Northern Ireland) Order 1977. The Board's functions are to fix the minimum rates of wages and certain other related matters such as holiday remuneration for agricultural workers in Northern Ireland.

Agricultural Workforce

2. The total number of persons working both full and part-time on Northern Ireland farms at 1 June 2005 was 51,100, a decrease of 4.13% on the 2004 total of 53,300. These decreases were recorded in each of the three main categories, that is, total farmers, total spouses and total other workers. Further details of employment are set out in the Appendix.

Activities of the Board

- 3. The Board held three meetings in 2004 and three in 2005, and made two Orders during this period. Order No's 83 and 84 increased the minimum rate of wages for all age groups by 5% and 4.3% respectively.

Appointments

5. Three appointments were made under Article 3 and Schedule 1 of the Agricultural Wages (Regulation) (Northern Ireland) Order 1977 during the period of this report. Mr W F Gillespie OBE was re-appointed as Chairman and Ms P Graham and Mr I McInnes were re-appointed as Ordinary Members. Appointments are for a two-year period effective from 1 April 2005.

Review of the Board

6. During the period of this report a Review of Public Administration was taking place in Northern Ireland. This review was set up to consider how the public sector should be administered. The scope of this review covered Executive Public Bodies including the Agricultural Wages Board. As a result it was not considered necessary to carry out the separate policy review, scheduled to take place in 2005, to look at the arrangements governing agricultural minimum pay & conditions and the future of the Board.

Minimum Rates of Wages

7. The following table shows the minimum rates of gross wages payable per 39 hour, five-day week to agricultural workers:

Holiday Entitlement

8. No amendments were made to holiday entitlement during the period of this report.

Enforcement of Minimum Rates

9. The Department of Agriculture and Rural Development is responsible for ensuring compliance with the provisions of the Agricultural Wages (Regulation) (Northern Ireland) Order 1977 and Orders made by the Agricultural Wages Board. Department Inspectors investigate complaints by workers about any matters within the remit of the Board's Orders. Complaints should be addressed to the Secretary, Agricultural Wages Board, Dundonald House, Upper Newtownards Road, Belfast, BT4 3SB.

Complaints

10. Six complaints from workers about non-compliance by employers with the Board's regulations were received during the period of this report. Following investigation, four of the cases were resolved. The two remaining cases are still under consideration.

Permits of Exemption

11. Article 6 of the Agricultural Wages (Regulation) (Northern Ireland) Order 1977 provides for the grant of a permit exempting an agricultural employer from the requirement to pay an infirm or incapacitated worker the full statutory minimum wage set by the Agricultural Wages Orders. Permits of exemption specify a lower minimum wage for these workers although the holder is not precluded from obtaining employment at a wage higher than that specified in the Permit. Permits are subject to a proviso that the rate of pay is not less than the National Minimum Wage rate.

12. It was determined that the agricultural permit arrangements were not compatible with the European Directive on the equal treatment for disabled people and other groups. As a result the one remaining permit of exemption issued on behalf of the Agricultural Wages Board was withdrawn on 30 September 2004 and no new permits were issued. During the period of this report Regulations to repeal Article 6 of the Agricultural Wages (Regulation) (Northern Ireland) Order 1977 were being prepared.

Costs of Administering the Order
