Public Expenditure 2006-07 Provisional Outturn

Total Managed Expenditure	This White Paper reports provisional outturn figures for public spending in 2006- 07 providing information on DEL and AME, including voted spending, near-cash and administration budgets. Outturn figures are reported for all departments as they were constituted at the end of 2006-07.
	Spending by the public sector as a whole is known as Total Managed Expenditure (TME). Within TME there are two important aggregates. Departmental Expenditure Limits (DEL) cover spending for which departments are set firm three-year plans in the Spending Reviews. Annually Managed Expenditure (AME) is subject to annual review as part of the Budget process.
Resource Accounting and Budgeting	With effect from 1 April 2001, Government spending moved from being accounted for on a cash basis to an accruals basis. This White Paper reports outturn for the main control aggregates and departmental control limits on an accruals basis and takes account of refinements to the budgeting system announced in Pre-Budget report 2005 (Cm 6701), that were introduced for control purposes from 2006-07. As noted above, the outturn figures are provisional and may be subject to adjustment when department's final accounts are available.
Consistency with other publications	The White Paper reports outurn against the budgetary control limits on the basis of the definitions used for control purposes in 2006-07. The figures differ in some respects from those given in Public Expenditure Statistical Analyses 2007 (<i>Cm 7091</i>) as that publication reflects changes to the budgetary framework introduced for control purposes from 2007-08. The major differences are that 2006-07 provisional outturn totals still report most impairments as part of the resource DEL and include profit and loss on asset disposals in the non-cash resource DEL rather than the capital DEL.
Central government voted expenditure	Provisional outturn in 2006-07 for voted resource spending was £400.844 billion – £9.255 billion (2.2 per cent) less than final provision and for voted cash spending £370.701 billion – £17.967 billion (4.6 per cent) less than final provision. Table 1 shows outturn, original provision and final provision by Estimate and Request for Resources (RfR). There was one overspend.
Departmental Ependiture Limits	Provisional outturn for resource DEL in 2006-07 was £292.651 billion, £0.749 billion (0.3 per cent) less than the Budget 07 estimate and £4.982 billion (1.7 per cent) less than final departmental limits. The near cash element of resource outturn was £272.492 billion, £3.340 billion (1.2 per cent) less than final departmental limits. Provisional outturn for capital DEL was £37.700 billion, 1.100 billion (2.8 per cent less than the Budget 07 Estimate and £4.893 billion (11.5 per cent) less than final departmental limits. Table 2 (resources), Table 3 (near-cash) and Table 5 (capital) show outturn against original and final limits by department. There were no breaches of resource or near-cash limits. One department breached the capital DEL. Limits can change during the course of the year for a variety of reasons including the draw down of End Year Flexibility (EYF) entitlements, transfers between departments and classification changes. Comparisons between provisional outturn and original limits can therefore be misleading. The outturn figures form the basis of the calculations to determine department's EYF entitlements for DEL shown in Table 6 .

Administration Budgets	Provisional outturn in 2005-06 for Administration Budgets was £16.061 billion. This is £0.641 billion (3.8 per cent) lower than final limits. Table 4 shows outturn, original and final administration budget limits for departments subject to administration costs control. There were no breaches.
Breaches	Whenever a breach of an individual DEL or administration budget occurs, the usual corrective procedures will be applied, including an investigation into the causes of the breach, an examination of the financial procedures of the department or body concerned and, where appropriate, a reduction in the corresponding limit in the following year.
End Year Flexibility	The DEL EYF scheme enables departments to carry forward all of their unspent DEL, including administration expenditure, with no upper limit. Eligible amounts are based on unspent DEL less, where appropriate, DEL Reserve claims plus any EYF entitlements from previous years not taken up. Table 6 shows the amounts carried forward into 2007-08 for departments as constituted at 27 June. Where Machinery of Government changes were announced on 28 June, EYF entitlements will be divided between the departments that assumed the functions of the former departments. Subject to Parliamentary approval of any necessary Supplementary Estimates, individual DELs or administration budgets will be increased when carry forward is taken up. Table 7 shows the movement in EYF stocks since the 2006-07 entitlements were announced in July 2006.
Annually Managed Expenditure	Provisional outturn for AME in 2006-07 was £1.658 billion (0.7 per cent) higher than the equivalent forecasts at the time of PESA 2007 (<i>Cm 7091</i>). Table 8 shows outturn for AME on the basis of the budgetary definitions in place during 2006-07.
