Thank you for your emails of 6 December 2013 where you requested the following information:

Ref 13/1740 - I would like to see any emails, papers, minutes, documents etc. relating to the DECC Permanent Secretary's May 2013 "Introductory meeting" with Horizon Nuclear Power/Hitachi Europe Ltd.

Ref 13/1741 - I would like to see any emails, papers, minutes, documents etc. relating to the Ed Davey's June 2013 meeting with Hitachi "to discuss energy and climate change issues"

Your requests have been considered under the Freedom of Information Act 2000 (FOIA).

In relation to request 13/1740: two emails, a note of the meeting and a briefing paper for the meeting have been located and are within the scope of your request. These can be found in Annex A.

In relation to request 13/1741: one email and a briefing paper for the meeting have been located and are in scope of your request. These can be found in Annex B.

Some information that is within the scope of your request is being withheld by the Department on the basis that it is exempt from disclosure under Section 43(2), Section 35(1)(a) and Section 40(2) of the FOIA.

Section 43(2) of the FOIA exempts information if its disclosure would, or would be likely to, prejudice the commercial interests of any person. The application of Section 43(2) to any given information request is subject to a public interest test – i.e. the public authority must

consider whether the balance of the public interest lies in favour of disclosure or in favour of maintaining the exemption and withholding it. In this context, we recognise that there is a general public interest in the disclosure of information, as greater transparency can make Government more accountable. Against this, however, there is a greater public interest in ensuring that the commercial interests of persons are not damaged or prejudiced by the disclosure of information which is not common knowledge and could adversely impact future commercial arrangements. Releasing certain types of information on the UKs new nuclear programme would prejudice the commercial interests of persons, would jeopardise future commercial arrangements within the nuclear industry, and indeed would be likely to dissuade developers from approaching Government to discuss commercial matters, none of which would be in the public interest. We have therefore concluded that, on balance, the public interest in this instance lies in maintaining this exemption and withholding certain information which is within the scope of your request.

Section 35(1)(a) of the FOIA, provides an exemption for information which relates to the formulation and development of Government policy. We are of the view that this exemption applies in this context because certain information that is in the scope of your request relates to the development of the Department's nuclear energy policy objectives and relates to the interplay between programmes underpinning those policy objectives.

The exemption in Section 35(1)(a) is also subject to the public interest test. In considering this, we recognise that there is an important public interest in the disclosure of information about the process of government policy formulation, particularly in the area of nuclear power, and recognise that disclosure may help promote greater understanding and transparency of Government. We also recognise that disclosing the information in question may help enhance trust in this area. However, there is also a very strong public interest against disclosing the workings of Departmental officials as they are attempting to formulate and establish Government policy going forward. When policy ideas are being raised, or have been raised for discussion and views and judgements sought, it is extremely important that officials have a safe space in which to consider these priorities, free from outside pressures, interference or the fear of premature disclosure. There is a need to ensure that Ministers and officials have the space in which to develop their thinking and explore options in communications and discussions without fear that their views will be disclosed to the public. This enables views to be tested and debated which can assist in stakeholder management, and which in itself enables more thorough policy development in the public interest. If officials are not permitted a safe space to consider these policy priorities there is likely to be a negative effect on the conduct of good government and there is a risk that decision making will become poorer and be recorded inadequately. Given the nature of the information, we have concluded in this case that, on balance, the public interest favours maintaining the exemption. Accordingly, some of the information that is within the scope of your request has been withheld on this basis.

Some personal information has been redacted from the information released. This information is exempt under section 40(2) of the FOIA as it constitutes 'personal data', and the disclosure of it would contravene one or more of the data protection principles. 'Personal data' can only be disclosed under the FOIA in accordance with the data protection principles which are set out in Schedule 1 of the Data Protection Act 1998. The first data protection principle requires that disclosure must be fair and lawful and must comply with one of the

conditions contained in Schedule 2 of the Data Protection Act 1998. We do not consider that it is fair and reasonable to release the names of individuals from third party businesses, or those who are not members of the Senior Civil Service, and do not consider that any of the relevant conditions in Schedule 2 are satisfied here. We have therefore redacted certain 'personal data' on this basis, but the names of Senior Civil Servants have been published.

OND brief for Stephen Lovegrove meeting with Horizon on 22nd May 2013

Points to make:

- Welcome Hitachi's entrance in to the UK new nuclear market, interested to hear from them on how their projects are progressing.
- Pleased to hear that preparatory work with ONR and EA has started to establish the timescales and resources required to assess the ABWR design
- Note Hitachi's commitment to UK content and the UK supply chain e.g. through MoUs with Babcock International and Rolls Royce and plans to establish a module assembly facility in the UK.
- I am aware that a Horizon Nuclear Supply Chain event is taking place in Gloucester tomorrow and that Michael Fallon will be in attendance to meet the senior team and deliver an address. I very much hope that the event is a success. As you know, accrued economic benefit to the UK arising from new nuclear is a key issue for the Government and to the local populations surrounding new build sites.

Lines to take:

Hinkley Point negotiations:

- As you are aware we are in negotiations with NNB Genco (a subsidiary of EdF Energy) about the potential terms of an Investment Contract (an early form of Contract for Difference) that might enable them to take a final investment decision on their Hinkley Point C project.
- There is clearly an interest in reaching an agreement on both sides, but no commitment to NNB Genco has yet been made by the UK Government, and neither side is obliged to pursue these negotiations.
- An Investment Contract will only be offered to NNB Genco if the deal is fair, affordable and value for money, as well as consistent with state aid, and in line with the Government's policy of no public subsidy for new nuclear. Any agreement will then be subject to Royal Assent of the supporting legislation and a positive state aid decision by the European Commission.
- There will be transparency over the terms of any Investment Contracts offered to developers of low carbon electricity, including new nuclear developers, and details will be laid before Parliament.

CfD Allocation Policy for new nuclear projects (post Hinkley Point C):

 We will be setting out our preferred policy in relation to post-Hinkley CfD allocation in July and will consult on CfD secondary legislation in Autumn 2013.

- Officials have been working to develop policy and will be meeting a team from Hitachi/Horizon on 30th May to discuss.
- At the moment I am unable to offer any detail on the likely policy as we have yet to seek ministerial approval for a preferred option. I would though be interested in your thoughts so that I can feed this into the policy development process.

Defensive lines:

- Government policy is that there will be no levy, direct payment or market support for electricity supplied or capacity provided by a private sector new nuclear operator, unless similar support is also made available more widely to other types of generation.
- The Government remains of the view that the contractual arrangements should largely be standardised across different low-carbon technologies, except for where some variations are required on a technology-specific, or similar, basis to ensure that a range of low-carbon technologies can come forward at a reasonable cost and in a manner that reflects distinguishable differences in risk profile.

Background:

Horizon - Key facts:

- Japanese technology firm Hitachi Ltd has acquired Horizon Nuclear Power, and plans to develop up to 7.8GW of new nuclear capacity in the UK at sites in Wylfa and Oldbury.
- Hitachi plan to build 2-3 reactors at each site with the first station in Wylfa coming online in the first half of the 2020s.
- Hitachi will be making use of their ABWR reactor design. On 15 January 2013 the Minister of State for Energy asked the ONR and the EA to start assessment work on the ABWR. ONR and the EA will now begin preparatory work with Hitachi and Horizon on the timescales and resources involved in assessing this new design.
- Babcock International and Rolls Royce have signed Memorandums of Understanding to join Hitachi to plan and deliver the programme.

Thank you for taking the time to meet with me on Wednesday. It was very helpful to be able to share with you the key issues that are front of our minds and to hear your thoughts on those and on progress more generally.

As I explained, we are seeking deeper engagement with your team on the development of EMR, particularly on the CFD framework ahead of its publication in July. Whilst we understand the pressures on your team at this time, we are keen to ensure we have a full opportunity to explain the areas where we have specific concerns, such as baseload reference prices, and to share our thoughts on how these could be addressed.
