

# MGN 334 (M) Amendment

## New National Boatmaster's Licence – Local Information and Local Knowledge

**Notice to all masters and owners of vessels operating commercially on inland waterways, and in limited coastal areas.**

*This notice should be read with MGN 334 issued January 2007 and MSN 1808.*

### **PLEASE NOTE:-**

Where this document provides guidance on the law it should not be regarded as definitive. The way the law applies to any particular case can vary according to circumstances - for example, from vessel to vessel and you should consider seeking independent legal advice if you are unsure of your own legal position.

### **Summary**

This amendment corrects the information on local requirements for the Broads.

### **1. The Broads local requirements**

- 1.1 Annex 1 of MGN 334 lists inland waterway authorities who have advised MCA about their local requirements, and lists those requirements.
- 1.2 This amendment corrects the list of local regulations/ byelaws for the Broads (as defined in the Norfolk and Suffolk Broads Act 1988).
- 1.3 Therefore, attached is a new table insert for the Broads. This should be inserted into MGN 334 and the previous information struck through.
