#### Item 4: DTCO 1381 – Replacing the buffer battery

During a 2 yearly Inspection Procedure you are reminded of the need to replace the buffer battery if the digital tachograph is a VDO DTCO 1381 unit. Vehicle Units where the buffer battery is irrevocably discharged will lose their program and cannot be re-activated. It is extremely important when changing the battery or performing a battery check, that you ensure that the DTCO 1381 is always connected to the on-board power supply (or to the power supply of the test equipment).

#### Item 5: GV215 Notice – Change of telephone number

The VOSA National telephone number has changed to **0300 123 9000** therefore the number show on a number of Form GV215 displayed on centres notice boards are incorrect. An updated copy is enclosed with this SN and must replace the copy on the notice board immediately.

#### Item 6: Malfunctioning workshop cards

With immediate effect any technician experiencing a malfunction with their workshop card that requires applying for a replacement using form D778b, are required to enclose with the form a letter explaining briefly the nature of the problems being experienced.

#### Item 7: Lisle Consult – Optical Switches

Lisle Consult has produced a pair of optical switches that have been accepted by VOSA for use with the Stoneridge MK II programmer. The optical switches are used in conjunction with surface mounted reflectors to start / stop the programmer in Fixed Distance Method 2. #### Item 8: Stoneridge Electronics – Digital tachograph fitment for H2 Hummer
