## **Re: Freedom of Information Request**

Thank you for your email of 18 May 2014 in which you requested the following:

"Please can you provide me with the following information under the Freedom of Information Act:

Since May 1st 2013, how many car journeys have ministers taken in ministerial cars, from where and to where.

Please provide your response in the following format: date, name of minister, from, to. "

Under the Freedom of Information Act 2000 ('the Act'), you have the right to:

- know whether we hold the information you require
- be provided with that information (subject to any exemptions under the Act which may apply).

The Department has only one ministerial car which is used by all the Department's Ministers for journeys when conducting official business. We cannot provide the information you have requested about these journeys as your request is too wide and the effort to administer your request would exceed the limit prescribed in Regulations made pursuant to Section 12 of the Freedom of Information Act 2000. This limit is £600 and which represents the estimated



cost of spending 3.5 working days in determining whether the Department holds such information, and locating, retrieving and extracting the information. Where the estimated cost is above this limit, we are not obliged to comply with a request.

Invoices are provided to the Department for journeys made in the Minister's car. In order to provide the information you have requested it would be necessary to identify every journey made by any of our Ministers over a period of more than a year, locate each invoice and extract relevant details. We estimate that it will take us in excess of 3.5 working days to determine appropriate material and locate, retrieve and extract the information in reference to your request. Therefore, your request will not be processed further.

You may wish to refine your request by narrowing its scope by being more specific about what information you particularly wish to obtain. You could, for example focus on information relating to a particular Minister, specific journey and shorter time period.

You may wish to be aware that the car is not used on a regular basis for journeys from ministers' homes to work and vice versa. The car may be required to pick ministers up from their home to attend to departmental business and papers. The Ministerial Code states that ministers are permitted the use of a government car for official business and for working on official papers during journeys between home and work. The Department does not hold information relating to the frequency of such journeys.
