

Care Bill Implementation Grant Determination (2014/15)

[No. 31/ 2325]

The Minister of State for Care and Support (“the Minister of State”), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination:

Citation

1. This determination may be cited as the Care Bill Implementation Grant Determination (2014/15) [No. 31/ 2325].

Purpose of the grant

2. The purpose of the grant is to provide additional support to local authorities in England towards expenditure lawfully incurred or to be incurred by them.

Determination

3. The Minister of State determines as the authorities to which the grant is to be paid and the amount of the grant to be paid, the authorities and the amounts set out in Annex A.

Treasury consent

4. Before making this determination in relation to local authorities in England the Minister of State obtained the consent of the Treasury.
