Thank you for your email dated 13 December 2014 in which you requested the following information:

"Can you please provide me with the following information:

When was your department's last 'sports day' and where was it held?

How many staff members from your department attended? Were they required to take the day off on annual leave?

How much did the event cost overall? Please provide a breakdown of what this money was spent on(e.g. venue, refreshments, medals, etc?

Please provide an itinerary of the day and any material (posters, for example) promoting the event to staff."

This has been considered as a request for information in accordance with the Freedom of Information Act 2000 (FOI Act)

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that information in scope of your request is held.

The information you have requested can be found below.

1. When was your department's last 'sports day and where was it held?

Currently this is an annual event and was last held on Friday 27th June 2014 in Bath.

2. How many staff members from your department attended? Were they required to take the day off on annual leave?

Approximately 1600 staff attended the 2014 event. Staff taking part in the sports day were entitled to request one days special paid leave for the event.

3. How much did the event cost overall. Please provide a breakdown of what this money was spent on (e.g. venue, refreshments, medals, etc)

The event cost approximately £70,000 (£9,000 on catering, £15,000 on facilities, £25,000 on accommodation, £2,000 on medals – the remainder on miscellaneous costs such as professional medical cover and waste disposal services). As the event is funded and run by an internal membership organisation, no public money is spent.

4. Please provide an itinerary of the day and any material (posters, for example) promoting the event to staff.



Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.


