A14 ACCIDENT STATISTICS BETWEEN A1 AND JUNCTION 37 AT NEWMARKET

Thank you for your email of 6 December to the Department for Transport asking for accident statistics for the A14 between the A1 and junction 37 at Newmarket under the Freedom of Information Act.

I confirm that we do hold the information. However, under Section 21 of the Act, we are not required to provide information which is already reasonably accessible to you. The information you request is available at <http://road-collisions.dft.gov.uk/>

To help you find the information you are looking for, please access the above link through your web browser. Then select the Collision Map on the right hand side of the screen. You will need to select Cambridgeshire as the highway authority in the drop down selector on the left hand side under Local Highway Authority. You may then choose the Year, Severity of Casualty, Casualty Age Band and Vehicle Type from the remaining drop down selectors. When finished, please click on Submit on the right hand side of the screen.

To see a more detailed map showing accident statistics on the A14, please click on one of the coloured roundels located along the area of interest. This will provide you with a more detailed map view of the area and you can use the zoom functions, which work in the same way as Google maps, to highlight areas of interest. A legend explaining the coloured roundels can be found below the map.

You also ask if we have carried out any studies into the impact of the camera installations on the A14. We have published two Post Opening Project Evaluation (POPE) reports. Information about POPEs can be found on our new website here: <https://www.gov.uk/government/organisations/highways-agency/about/research>

POPEs were published for both completed average speed cameras schemes between Huntingdon and Cambridge and between Fen Ditton and Girton. Again, under Section 21 of the Act, we are not required to provide information which is already reasonably accessible to you.
