Request for Information: Air Pollution

Thank you for your email request for information about air pollution, which we received on 22 April. We have handled your request under the Environmental Information Regulations 2004. You asked for:

- A copy of the minutes of the Secretary of State's meeting with the Mayor of London on 1
 May 2013 to discuss air quality, as well as the minutes of any subsequent meetings on this
 subject
- Copies of correspondence between the Secretary of State and the Mayor of London on air quality/air pollution in the last two years

I have established that no record was kept of the meeting of 1May 2013 and I am therefore unable to provide the information you have requested. There has been no subsequent meeting on this subject.

On your request for copies of correspondence between the Secretary of State and the Mayor of London, I have provided in the attached zip file, copies of letters (8 in total) dated; 18 June 2012, 5 July 2012, 25 September 2012, November 2012, August 2013, 1 August 2013, 4 March 2014 and April 2014.

Please note that some of this information has been withheld for the following reasons:

• It is personal information: we have decided that the names of officials constitute personal data relating to third parties. Regulations 12(3) and 13(1) of the EIRs provide that personal data relating to third parties is exempt information if disclosure would breach the Data Protection Act 1998 (DPA). These names have therefore been redacted from the attached documents.

In keeping with the spirit and effect of the Environmental Information Regulations and in keeping with the government's Transparency Agenda, all information is assumed to be releasable to the public unless exempt. Therefore, the information released to you will now be published on www.gov.uk together with any related information that will provide a key to its wider context. Please note that this will not include your personal data.
