## **AUTHORIZED AMENDMENT**

This NAA relates to the the publication of RA 3037, which is a new regulation covering SSR Alone operations and is designed to replace the information currently contained in RA 3035(7) and Chapter's 11 and 35 of the MMATM. RA 3037 clearly identifies defined roles and responsibilities for Aviation Duty Holders and Duty Holder Facing Organizations in regards to the acceptance and provision of SSR Alone Air Traffic Services (ATS). The introduction of RA 3037 will ensure the full range of ATS can continue to be provided utilising SSR Alone.

This NAA also covers the changes to the MMATM that are required as a result of ScATCC(Mil) closing and their task, including the role of Distress and Diversion (D&D) Cell, being taken on by LATCC(Mil). These are minimal changes to remove references to ScATCC(Mil) as an independent unit with all references being replaced by LATCC(Mil), now the sole provider of D&D and Area Radar Services.
