Purpose of This Document

1. This document provides information about the 2013/2014 Learning Aims Reference System (LARS) Hierarchy file.

Changes to the LARS Hierarchy file from the 2012/2013 LARA Hierarchy File

2. The field names have been changed to match those used in LARS.

Purpose of the LARS Hierarchy File

3. The LARS hierarchy file provides a static set of learning aims information that is used by us when producing qualification success rate and minimum standards reports for classroom learning and workplace learning. The LARS hierarchy file can be used by providers and software developers who wish to produce their own classroom learning or workplace learning success rate reports.

Contents of the LARS hierarchy file

- 4. The LARS hierarchy file contains data for each learning aim on the LearningDelivery table of the LARS database as at the end of the 2013/2014 LARS maintenance period, which is 24/10/2014.
- 5. LARS only holds the details of aims and frameworks that can be used in the 2013/2014 ILR. As success rates are produced for three years (2011/2012, 2012/2013 and 2013/2014) aims from earlier years may not be present in the LARS hierarchy file. It may be necessary to use the Learning Aims Reference Application (LARA) Hierarchy file for 2012/2013 to obtain the data for these aims.

Date of Production

6. The LARS hierarchy file for 2013/2014 was published at the beginning of November 2014.

 - Microsoft Access (.MDB)
