Your email dated 12<sup>th</sup> May 2014 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

*I am looking for some information of contract wins with a value in excess of £100 million over the last 4 years and the companies to whom they were awarded to. In addition would it be possible to provide the names of the short-listed companies who also bid on these contracts?*

I can confirm that the Ministry of Defence (MOD) holds information relevant to your request. Since 1<sup>st</sup> April 2010, the MOD has awarded 17 competitive contracts which have a value in excess of £100 million. Details of these contracts, including the names of the short-listed companies, are given in the table at the Annex. Excluded from the table are Non-Competitive contracts, contracts with Defence Science and Technology Laboratories (Dstl) let under a Terms of Business Agreement, and Pan-Government enabling contracts that are let by Central Government and not the MOD, but which appear in the Defence Business Services Liverpool database because MOD does make payments against them.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1<sup>st</sup> Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail [CIO-FOI-IR@mod.uk](mailto:CIO-FOI-IR@mod.uk)). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
