Information released

The information requested from the financial year 2010-11 onwards is held by this Department.

BIS was formed through a machinery of Government change which occurred in June 2009. The department was created by merging the Department for Business Enterprise and Regulatory Reform (BERR) and the Department for Innovation, Universities and Skills (DIUS). The information below has been drawn from various data sources and provides details of both the former departments which were merged to create the Department for Business, Innovation & Skills (BIS). However we do not hold full year overtime data or spend on temporary/agency staff for 2009-10 for BIS and the previous departments.

1. The total overtime payments in core BIS (including UK Trade & Investment) are shown in the following table:

- 3. There are two types of award/bonus within BIS.
- In-year awards which recognise strong performance in particularly demanding tasks or situations. These were suspended from 2010 -11 and re-instated in November 2011.
- Annual performance awards which reward staff based on their annual performance rating.
