### Background

#### **Opinions and Lifestyle Survey**

The ONS Opinions and Lifestyle Survey is a national cross-sectional survey, which provides a snapshot of views and opinions. It currently runs eight months of the year, and conducts around 1,100 interviews each month. It is a fast way of obtaining information, with data available within a month of fieldwork ending.

The DWP commissions a disability module to be run on this survey asking questions on a number of themes. One of the themes the survey focuses on is Paralympic attitudes.

#### **Policy Context**

The Government wants to promote positive attitudes and behaviours towards disabled people to enable participation in work, community life and wider society, tackling discrimination and harassment wherever it occurs.

One of the aims of the Paralympic Legacy is to help transform the attitudes and perceptions of disabled people. This is also a core strand of Fulfilling Potential, the cross-government disability strategy. The Legacy and strategy are using the positive impact of the Games as one of the drivers to change attitudes and perceptions towards disabled people.

# Methodology

This data shows figures from 2013, and the first quarter of 2014 (January, February and March 2014). All data is for the UK.

At the beginning of 2014 we changed the Paralympic question asked on the survey. This was done so that the questions better reflect the work around the Paralympic legacy. Comparisons between 2013 and 2014 data should not be made.

#### Definition of disability

Disabled people are defined in accordance with the Disability Discrimination Act.

#### Weighting

We have used an individual weight on this data. This weight controls for the unequal probability of selection, as the likelihood of a household with only 1 or 2 adults being selected is higher than that of a household with many adults.
