Thank you for your email of 10 September 2014 requesting the following information:

"I understand that there is a training on civilian life and careers and that the forces as part of a MOD run resettlement process.

I would be grateful if you could provide me with a summary (preferably in an excel format) of the civilian roles for the last number of years which ex-forces have expressed an interest by number (or %) of people leaving the forces; ideally by rank as well. (eg For 2013 - 10% wish to work in logistics, 5% in the medical profession, 15% in security. For 2012 – 9% in logistics, 7% in medical profession, ...).

I do not wish to burden the MOD unnecessarily and so would be happy with a list of the number of attendees on each services provider courses which the MOD (and other public funds administered but the MOD) has funded. I believe these details will be completed by the relevant leaver on Parts 1 & 2 of the MOD form 1746 (04/12) of Annex N to the JSP 534 (the Tri-Service Joint Resettlement Manual)."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD). However, I have to advise that we are unable to answer your request exactly as presented above without exceeding the appropriate cost limit as we do not hold the data in a manner that enables statistics to be compiled to answer your request.

For example; completed copies of the MOD Form 1746 you refer to in this FOI request are not retained centrally. The single Services decide whether to retain these Forms and for what period. To extract data from MOD Forms 1746 completed by Service personnel at the time they approach the end of their military service would involve accessing each record separately. Such a manual trawl of individual personnel records for those who have left the armed forces would incur disproportionate costs.

Furthermore I must advise that even if such action could be undertaken, it is unlikely that the MOD Form 1746 will meet your request. It is known that sometimes Service personnel attend courses such as plumbing or plastering so that they can work on their own houses after they've left the Services, but might not follow this as a career.

Section 12 of the FOI Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for central government is set at £600. This represents the estimated cost of one person spending 3.5 working days in determining whether the department holds the information, and locating, retrieving and extracting it.

However, under Section 16 of the FOI Act (Advice and Assistance) I can advise that the Career Transition Partnership (CTP) holds limited statistics relating to Service personnel who attend contract funded courses. Although this data does not meet your FOI request completely, it is provided in the tables at Annex A to this response as this may be helpful.

The MOD has also published statistics on the estimated employment outcomes for ex-service personnel who use the services provided by CTP. If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, 1st Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
