### AGO Vision

The Attorney General's Office (AGO) supports the functions of the Attorney General and the Solicitor General (the Law Officers) to the highest professional standards in line with the AGO values:

The role of the Attorney General includes:

- promoting the rule of law at home and overseas;
- acting as Chief Legal Adviser to Government, Parliament and the Crown;
- Cabinet level membership of the Government;
- superintending and having general oversight of public prosecutors and government litigation;
- working with the Justice Secretary and Home Secretary to provide a more efficient, effective and accountable justice system;
- carrying out independent public interest litigation functions; and
- acting as leaders within the legal professional world including leadership of the government legal profession.

The Attorney General also holds the separate office of Advocate General to Northern Ireland.

<b>Superintending the public prosecutors</b>
<ul style="list-style-type: none"> <li>• fulfilling the Law Officers' statutory obligations to superintend the Crown Prosecution Service (CPS) &amp; Serious Fraud Office (SFO) including by recruiting a new Chief Inspector, HM Crown Prosecution Service Inspectorate;</li> </ul>
<ul style="list-style-type: none"> <li>• ensuring the Law Officers' are able to secure sufficient resources for the CPS and the SFO through effective engagement with HM Treasury and are assured of effective management of resources through engagement with the National Audit Office;</li> </ul>

<b>Working with the Justice Secretary and Home Secretary to provide a more efficient, effective and accountable justice system</b>

<ul style="list-style-type: none"> <li>• engaging with criminal justice partners on the development and implementation of a criminal justice efficiency reform programme which supports the CPS and SFO's ability to deliver casework within their spending review provisions.</li> </ul>
<b>Public interest functions</b>
<i>Prosecutions</i>
<ul style="list-style-type: none"> <li>• referring potentially unduly lenient sentences to the Court of Appeal;</li> </ul>
<ul style="list-style-type: none"> <li>• considering requests for consent to prosecute where the Attorney General's consent is required;</li> </ul>
<ul style="list-style-type: none"> <li>• providing leadership on the advocacy of the law on contempt and bringing proceedings for contempt of court;</li> </ul>
<ul style="list-style-type: none"> <li>• considering applications to stop a prosecution on indictment by entering a <i>nolle prosequi</i>;</li> </ul>
<ul style="list-style-type: none"> <li>• referring points of law to the Court of Appeal after an acquittal in criminal cases</li> </ul>
<ul style="list-style-type: none"> <li>• promoting international cooperation between prosecutorial authorities.</li> </ul>
<i>Administration of Justice</i>
<ul style="list-style-type: none"> <li>• taking action to restrain vexatious litigants; intervening in the public interest in certain charity and family law cases;</li> </ul>
<ul style="list-style-type: none"> <li>• considering requests for consent to make an application to the High Court for new coroner inquests;</li> </ul>
<ul style="list-style-type: none"> <li>• exercising the discretion to appoint "advocates to the court", "special</li> </ul>

advocates” and “special counsel”.
<b>Legal professional leadership</b>
<ul style="list-style-type: none"> <li>maintaining good relationships with the professions: judiciary, Bar, Law Society including through an effective programme of meetings, briefings and visits to promote co-operation between them in the efficient and fair administration of justice, and understanding and support for Government initiatives.</li> </ul>
<ul style="list-style-type: none"> <li>Supporting the Treasury Solicitor and Law Officers in leadership to and accountability for the wider Government Legal Profession.</li> </ul>
<b>Delivering the priorities</b>
<ul style="list-style-type: none"> <li>providing excellent legal resources to the Law Officers;</li> </ul>
<ul style="list-style-type: none"> <li>maintaining excellent working relationships in Whitehall, with the superintended departments and prosecutors;</li> </ul>
<ul style="list-style-type: none"> <li>managing delivery of the Law Officers’ Parliamentary business;</li> </ul>
<ul style="list-style-type: none"> <li>effective and professional press and communications activity to explain, promote and defend the work of the Law Officers and the Department, foster transparency and accountability, and support staff engagement.</li> </ul>
