Some of these attributes are new to this year's British Behaviour Abroad report, which has contributed to the increase in cases compared to 2012/13.

REPORT FINDINGS AND FOREIGN & COMMONWEALTH OFFICE TRAVEL ADVICE

HOSPITALISATIONS

Report findings:

- Spain remains the country with the highest number of British nationals hospitalised (675 cases) but the number has reduced significantly compared to last year, with a 24% decrease.
- The overall number of hospitalisation cases is lower than last year, including in popular holiday hotspots such as Greece (11%), Portugal (27%) and Cyprus (14%).
- Hospitalisation cases in France have reduced by 26% (to 156 cases). Part of this decrease might be attributed to a fall in ski-related incidents.
- Consular staff have continued to work closely with local hospitals and partner organisations to ensure they provide the right support, and we have also implemented successful prevention campaigns on issues such as alcohol and the importance of being covered by travel insurance all of which may have had an impact.
- Proportionally British nationals are most likely to be hospitalised in the Philippines, which saw a 38% increase in cases (to 47 cases).

FCO advice:

- Research the health risks of the country you are visiting as soon as possible before travelling, so you can
 get the right vaccinations and preventative measures (e.g. malaria tablets) if required. Visit

- Ensure your medication is legal in the country you are visiting contact the Embassy of the country to which you are travelling and visit <u>http://www.nathnac.org</u> and <u>www.nhs.uk</u> for more information.
- Check the small print of your travel insurance policy to make sure you are covered for holiday activities such as moped or quad bike hire, and remember that most insurers won't pay out if you injure yourself or others when under the influence of alcohol.

DEATHS ABROAD

Report findings:

- The total number of death cases we recorded was significantly lower in 2013/14 compared to 2012/13 (6,193 to 4,110 cases a 34% reduction). This was due largely to a change in the way our consular staff record cases: we no longer record death notifications (where we have had no other involvement) as consular cases. By working more closely with hospitals and partner organisations we are ensuring people get a better service and allowing our frontline staff to focus on our most vulnerable customers.
- The country with the highest number of deaths of British nationals recorded was Spain (856 cases), followed by Thailand (362) and France (346).
- As a proportion, British nationals remain significantly more likely to die in the Philippines than in any other country. This is due to the large number of elderly British expats who live there, a group which continues to account for most of the hospitalisation or death cases. Relatively few tourists die or are hospitalised.

FCO advice around death abroad:

- No matter how old or how fit you are, take out comprehensive travel insurance if an uninsured person dies whilst abroad any treatment they have received and their repatriation to the UK is unlikely to be covered. Bringing a body back to the UK can cost thousands of pounds.
- If you are living in the UK and a relative or friend dies when abroad, you should contact the FCO on 020 7008 1500. If you are abroad, you should contact the relevant Embassy, High Commission or Consulate.
- It is essential that the death is registered in the country where the person died. The FCO can advise you how to do this. The FCO can also advise you about bringing a body and personal belongings back to the UK and provide support during this distressing time.

RAPE AND SEXUAL ASSAULT

Report findings:

- Overall there was a 23% decrease in reported rape cases compared to 2012/13. The 106 cases we dealt with in 2013/14 was the lowest number we have recorded in a decade.
- There was also a 12% decrease in the number of reported sexual assaults, with the total number of sexual assault cases at its lowest in four years.
- The highest number of reported sexual assaults occurred in Spain (18 cases), but this still represented a decrease of 54% compared to the previous year (39 cases). There was also a decrease in the number of reported rape cases in Spain, from 31 in 2012/13 to 22 (a reduction of 29%).
- There was a 65% fall in the number of reported rape cases in Turkey, where FCO consular and specialist staff have been working with local authorities and partners to help minimise the risk to tourists and improve the handling of these cases when they do happen.

FCO advice on rape and sexual assault abroad:

• We encourage anyone who is a victim of rape or sexual assault overseas to contact their nearest Embassy

- We can offer support in a number of ways including explaining local procedures, accompanying people to the police station, helping them deal with local authorities and medical staff and contacting friends or family at home if requested.
- We would encourage people to take the same precautions they would at home to avoid putting themselves at risk for example keeping an eye on their friends; never accepting car rides from strangers, and asking their hotel to recommend a taxi firm; and never leaving food or drinks unattended, so they can't be spiked.

ARRESTS, DRUG ARRESTS AND DETENTIONS

Report findings:

- There was a slight decrease (of 17 cases) in the overall number of arrests recorded in 2013/14 compared to the year before. Most cases were handled in Spain (1,389), followed by the USA (1,153) and the United Arab Emirates (261).
- Although the total number of arrests globally has decreased, some countries have seen an increase in cases, including the Philippines, Egypt and France.
- Drug arrests involving British nationals abroad have increased by 7% to 717, following the significant drop last year (669). However, the number of cases remains low compared to recent years.
- Most drug arrests were handled in Spain with 173 cases, a 68% increase on the previous year (103 cases), which may be attributed to an increase in local authority action. The second largest number of arrests were recorded in the USA with 111 cases, a 30% decrease on the previous year.

FCO advice:

• Don't take risks with the law abroad – or you could end up throwing years of your life away in a foreign prison.

- Think about what you are doing at all times and trust your instincts do not take risks that you would not at home. Many countries have a zero-tolerance approach to offences involving drugs and alcohol and sentences can be long.
- It is a good idea to research the local laws and customs of the country you are visiting there may be serious penalties for breaking a law that might seem trivial at home. Advice relating to country-specific local laws and customs can be found at www.gov.uk/foreign-travel-advice.

OTHER ASSISTANCE

Report findings:

- The total recorded cases of other types of assistance increased to 4,488 in 2013/14 (up from 3,707 in 2012/13 an increase of 21%), driven by the addition to this category of several attributes new to the British Behaviour Abroad report this year.
- There was a rise in recorded cases involving British nationals with mental health needs, from 383 to 442 an increase of 15%. The countries with the highest number of cases were Spain, France and the USA.

FCO advice:
