## Safe Use of Petrol Cut Off Saws

Skanska, STIHL and CSkills Awards have joined forces to develop a new training programme and accompanying video to promote the safe use of petrol driven cut-off saws in the construction industry.

## CPC Deadline looming

The CPC, or 'driver certificate of professional competence' is an initiative that hopes to help keep drivers, and the public, safe by making regular training a mandatory requirement for any professional driver who drives a vehicle over 3.5 Tonnes.

All drivers, new and existing, must now undertake 35 hours of training every five years to ensure that their Driver CPC remains valid. This training must be delivered in blocks lasting a minimum of seven hours, and covers subjects such as road safety, fuel economy, health and safety and service. And if you or your drivers haven't completed CPC training yet, time is running out, as the deadline for completing the first 35 hours of training is the 10 September 2014.

There are a number of different courses that are available to make up the 35 hours total training time but in particular the Highways Agency would be keen for professional drivers to undertake a course on protecting vulnerable road users.

## M1 J28-31 Safety Stand down

Costain held a safety stand down day on 12 May, to provide a high impact safety message focusing on a theme of behavioural safety, to the entire 350 strong site team included representatives from the Highways Agency, designers Mouchel, supply chain partners as well as direct operatives, supervisors and engineers.

The day started with a series of presentations from the project management team including feedback on the recent climate survey and information about current safety trends on the site. Costain's CBS team also presented some examples of how the behavioural approach to safety works including examples of some

recent successes on the M1. The event continued with a fictional scenario played out by actors illustrating the potential impact that a serious safety failure could have on the M1 project – in this case an unqualified driver hitting an operative whilst driving an overladen dumper. The actors (in character) also faced questions and challenges from the floor, with some heated exchanges ensuing.

The fictional scenario concluded with a courtroom scene featuring Gerard Forlin QC, a specialist Health and Safety barrister, who then went on to talk about current trends emerging from recent cases. There was a sobering conclusion to the day as Paul Blanchard, a construction worker paralysed from the chest down following a fall from height in 2010 spoke of his personal story and brought home the

human cost that an accident at work can have.

Arun Sahni, the Highways Agency representative on the project said "It's great to see Costain taking the initiative to promote behavioural safety on this scheme. The level of commitment and investment in the day has sent a clear message to everyone involved in the project that safety is our top priority"
