1. What is the total government revenue generated as a result of Driver CPC. This is to include upload fees (i.e. £1.25 per hour), centre approval, course approval and re approvals and any other income generated. Please can I have all these numbers separately.

The table below shows the revenue generated by driver certificates of professional competence (Driver CPC) fees. Please note that the figures below are based on the year in which the payment was received and will contain prepayments for future services; as such, they will do not match the income recognised in DSA's statutory accounts.
