The attached table shows total number of fish imported by the UK in 2012, 2013 and 2014 under commodity codes 030110 and 0301190. These two commodity codes are used for marine fish and some other species of fish.

Therefore, the information released to you will now be published on www.gov.uk together with any related information that will provide a key to its wider context.
