Annex B: Impact Assessment

- Section 9 of the Academies Act 2010 (later as amended by the Education Act 2011) places on duty on the Secretary of State to take into account what the impact of establishing the institution would likely be on maintained schools, Academies, institutions within the further education sector and alternative provision in the area in which the institution is (or is proposed to be) situated. Any adverse impact will need to be balanced against the benefits of establishing the new school.
- We have carried out an Impact Assessment (see Annex B1) which concludes that the impact on most local schools should be minimal to moderate. Two schools, Buckingham and Cottesloe, are at a high general risk of losing a significant number of pupils.
- 3. Buckinghamshire County Council has been concerned about the impact of multiple offers, has regularly asked for progress on a funding agreement, and questioned the logic of a 140 pupil admission number in the Free School's first year of opening. Officials responded to say that we are close to entering into a funding agreement, but will only do so if we are satisfied of reasonable demand from parents for pupil places and likely financial viability of the Free School. On 20 May 2013, we provided the Trust with a letter of comfort to confirm that the Department is satisfied with the school's progress.
- 4. Milton Keynes and Oxfordshire local authorities were also sent letters on 25 February seeking their views on whether Sir Thomas Fremantle Free School should enter into a Funding Agreement with the Secretary of State for Education. We received no objections to the Free School.
- 5. We conclude that it is appropriate for the Secretary of State to enter into a Funding Agreement with the Free School Trust in light of the possible impacts on the basis that:
 - A. The additional school will be likely to improve standards in the area;
 - B. Wider developments in Winslow, Buckinghamshire, will likely bring an increased pupil population in future years.
 - C. The additional school will give parents greater choice and will offer something different to existing schools. It will specialise in technology, sport and offer an extended school day.
