

Self Assessment ‘Test in Live’ Information

Background

The ‘Test in Live’ (TIL) functionality is essentially a testing facility for users. It allows users to submit files to the Live Gateway using Live credentials but no HMRC systems are updated.

Any submissions identified as TIL are validated and treated as Live submissions. The validation responses are identical to Live returns but as this is a test service will result in a dummy IRmark receipt being returned in the success_response. A normal error message will be returned if the TIL submission is unsuccessful.

What is required

To submit a TIL submission to the Live service the following details should be included in the file:

You can also submit a TIL submission to either VSIPS or TPVS. Remember you are effectively sending a ‘test’ to the Test service but this will enable you to check the functionality of your product before you release it. Details below for info:
