AUTHORIZED AMENDMENT

- 1. The applicability of the RA 4800-4849 series (MRP Part 145) has been increased to include Military Maintenance Organizations (MMOs), as well as its previous applicability to contractor-run maintenance organizations, known as Approved Maintenance Organizations (AMOs). This has been necessary to harmonize the regulatory requirements on military and contractor maintenance.
- 2. The regulation of MMOs is now more closely aligned to the regulation of AMOs. Therefore, several regulatory requirements have been subject to change.
- 3. As a result of this work, a number of RAs within the RA 4009-4702 series have been withdrawn, since their content has been absorbed into the RA 4800-4849 series.
