## MAC Construct, Creation and Assignment

1. The Materiel Asset Code (MAC) which is formed from the data elements shown in Fig 3.0 will continue to be the basis for MAC construction.

2. Existing MAC that have been previously issued will remain extant but new MAC will be constructed using the data in the following tables. If a new to service equipment has related equipment with an existing MAC every attempt will be made to match the liability code of the new equipment to the existing equipment.


