

## **2013 to 2014 Final Delivery Position Publication Field Information**

### **Publication\_Number**

This is the Agency-related field that tracks any documents or information that we publish.

### **UK Provider Register Number**

The UK Register of Learning Providers (UKRLP) is a 'one-stop' portal for government departments, agencies, learners and employers to share key information about learning providers. The UKRLP allows colleges and training organisations ('providers') to update their information in one place and share this across agencies such as the Skills Funding Agency, the Higher Education Funding Council for England (HEFCE) and the Universities and Colleges Admissions Service (UCAS).

We use the UK Provider Register Number (UKPRN), which is verified by UKRLP, as part of our due diligence processes ahead of contracting with a provider. Each learning provider has a unique UKPRN, which they must use to submit data to us through the Individualised Learner Record (ILR).

### **Provider\_Name**

The provider name is the name of the legal entity with whom we will enter into contract. We verify the provider name by using Companies House, UKRLP and audited accounts information that the providers supply.

## **Funding\_Line**

In the funding year 2013 to 2014 the Adult Skills Budget (ASB) comprises the following:

- adult apprenticeships
- other workplace learning
- classroom learning
- Additional Learning Support
- Formal First Step

In the funding year 2013 to 2014 Discretionary Learner Support also includes the 24+ Advanced Learning Loans Bursary.

In the funding year 2013 to 2014 Community Learning comprises:

- Personal and Community Development Learning
- Family, English, Maths and Language (previously known as Family Literacy, Language and Numeracy)
- Wider Family Learning
- Neighbourhood Learning in Deprived Communities

In the funding year 2013 to 2014, we manage 16 to 18 apprenticeships on behalf of the Education Funding Agency. This includes Agency-funded 16 to 18 traineeships. We show the funding for 16 to 18 apprenticeships separately.

## **Delivered\_or\_Funded**

We calculate the value of activity that providers have earned during the funding year (the delivered value) using verified ILR data that providers supply. We then compare those earnings to the providers' contract value and apply our published reconciliation policy to calculate the value of activity that we will fund (the funded value).

## **Value**

This is the delivered or funded value shown in pounds (£).
